

JOHN AND TAMMY'S ROAD TO STAGECOACH CONTEST RULES

These contest rules are specific to the above contest conducted by Audacy California, LLC d/b/a KSON-FM (collectively, the "**Station**"). Except to the extent specifically set forth below with respect to this specific contest, the Station's general contest rules apply to this contest as well. How to Enter

From 5:00 AM (PT) on March 23, 2026 through the earlier of either at 7:00 PM (PT) on April 21, 2026 or the point at which one hundred (100) prizes have been awarded in this Contest, whichever is sooner, go to www.kson.com/contests, click on the link to enter this Contest, and complete the entry form with all applicable and required information.
