

KLUC - Disney “Song of the Day” Summer 26’ Contest Rules

These contest rules are specific to the above contest conducted by Audacy Nevada, LLC d/b/a KLUC (collectively, the “**Station**”). Except to the extent specifically set forth below with respect to this specific contest, the Station’s general contest rules apply to this contest as well. Entry/Winning

1. No purchase or payment of any kind is necessary to enter or win the KLUC Disney “Song of the Day” (the “**Contest**”). A purchase or payment will not increase your chance of winning.
2. Listeners can enter the Contest by listening to the Station weekdays (Monday – Friday) (excluding holidays) between Monday, April 27, 2026 through Friday, May 1, 2026 between approximately 10am PST and 3pm PST each day by listening for the Station on-air personality to say the “Song of the Day”. The “Song Of The Day” will be announced in the 10:00am (PT) hour only and will not be repeated. The “Song of the Day” is scheduled to be played between approximately 11am and 12pm and again between 2pm and 3pm. After the song of the day is played, caller number 25 at (702) 364-9898 will, upon confirmation of eligibility, win the Qualifying Prize (as described in Section 6 below), (each a “Qualifying Prize Winner”) and be qualified to win the Grand Prize (as described in Section 7 below). The maximum amount of all prizes awarded in this Contest is limited to nineteen (19) qualifying prizes and one (1) grand prize.

3. On Monday, May 4, 2026 at approximately 9:00am (PT) one (1) Qualifying Prize Winner will be selected in a random drawing of all Qualifying Prize Winners, and subject to verification of eligibility and compliance with these Contest Rules, will become a “**Grand Prize Winner**”.
4. There will be up to, but in no event more than, nineteen (19) verified Qualifying Prize Winners in this Contest. There will be up to, but in no event more than, one (1) Grand Prize Winner in this contest.
5. Odds of becoming a Winner depend upon the number of calls received for any particular Contest Play.

Prize(s)

6. Each of the up to nineteen (19) Qualifying Prize Winners in this Contest will each receive four (4) Disneyland Resort 2-Day, 1-Park per day tickets (tickets must be used by June 15, 2027) (each a “**Qualifying Prize**”), valued at approximately \$1,320.00 and is courtesy of Disney Destinations, LLC.
7. The up to one (1) Grand Prize Winner in this Contest will receive one (1) Disneyland Resort vacation package consisting of the following: (i) hotel accommodations for the winner and up to three (3) guests (one (1) standard room/quad occupancy, including room tax, subject to certain room availability) for up to two (2) consecutive nights at one of the Hotels of the Disneyland Resort, as selected by Disney in its sole discretion (standard daily hotel parking at the premises is not included unless winner resides on the island of Oahu); (ii) two (2) nights parking for one vehicle; and (iii) four (4) 3-Day, 1-Park per day tickets to the Disneyland Resort (package must be used by June 15, 2027), (the “**Grand Prize**”).
