

104.3 The Score Suite Stakes Contest Rules

These contest rules are specific to the above contest conducted by Audacy Illinois, LLC d/b/a WSCR-AM and WSCR-FM/104.3 The Score (the “**Station**”). Except to the extent specifically set forth below with respect to this specific contest, WSCR’s general contest rules apply to this contest as well. A copy of these specific contest rules and the Station’s general contest rules are available on the contest page on the Station’s website at www.thescorechicago.com/rules. To the extent the general contest rules differ from these rules, these rules will govern and control with respect to this contest.

How to Enter and Win

1. No purchase or payment of any kind is necessary to enter or win the “104.3 The Score Suite Stakes” contest (the “**Contest**”). A purchase or payment will not increase your chance of winning.
2. To be eligible to participate in this Contest, entrants must be legal U.S. residents of Illinois, Indiana, and Wisconsin and 18 years of age or older as of the date of entry in this Contest.
3. Starting on Wednesday, April 29, 2026 and ending on Friday, May 8, 2026, listen on weekdays (Monday – Friday) between 5:30am (CT) and 5:59pm (CT) for the Station to announce the cue to call. There will be a minimum of at least two (2) and a maximum of up to, but no more than, four (4) cues to call at random times each day. At the time of the cue to call, caller 6 to the Station contest line at 312-540-0670 will, upon verification of eligibility and compliance with these Contest rules, qualify for the chance to win the one (1) Grand Prize (as described in Section 17 below) (each, a “**Qualifier**” and collectively, the “**Qualifiers**” in this Contest.
 - i. **Calls to other numbers, other than the announced number, including the Station’s general number, will not be accepted.**
 - ii. **WARNING! DUE TO DELAYS IN THE ONLINE STREAMING OF THE STATION’S BROADCAST SIGNAL, LISTENERS TO THE ONLINE STREAM MAY NOT BE ABLE TO PARTICIPATE IN, OR MAY BE DISADVANTAGED IF PARTICIPATING IN, ANY CONTEST THAT REQUIRES POTENTIAL ENTRANT(S) TO LISTEN TO THE STATION. CONTEST PARTICIPANTS SHOULD NOT RELY ON STREAMED BROADCASTS.**
4. **A PERSON MAY BECOME A QUALIFIER ONCE IN THIS CONTEST, AND OBTAIN ONLY ONE (1) QUALIFIER SPOT IN THE GRAND PRIZE EVENT. ONCE A PERSON OBTAINS A QUALIFIER SPOT IN THIS CONTEST, THEY WILL BE DISQUALIFIED IF SELECTED AGAIN AS A POTENTIAL QUALIFIER.**
5. **ONLY THE ACTUAL ENTRANT WHO ENTERED THIS CONTEST CAN BE A QUALIFIER. ENTRANTS CANNOT TRANSFER OR ASSIGN THEIR QUALIFYING SPOTS TO OTHER PERSONS.**
6. Any Qualifier must be present at the Grand Prize Event (as described in Section 9 below) to participate in the grand prize reverse drawing during the Station live broadcast on Thursday, May 14, 2026. Any Qualifier who fails to appear at the Grand Prize Event by the required deadline as stated in these Contest rules will be disqualified and will not receive any alternate contest attempts, prize substitution or compensation. The Station reserves the right in its sole discretion to change the date, time or location of the Grand Prize Event (as described in Section 9 below). Difficulties with getting to the Grand Prize Event (as described in Section 9 below) is not the responsibility of the Station.

7. There is no prize associated with being a Qualifier in this Contest.
8. There will be up to a maximum of up to thirty (30) Qualifiers in this Contest.

How to Win

9. To be eligible for the Grand Prize (as described below in Section 17 below), Qualifiers must attend the live broadcast and grand prize drawing on Thursday, May 14, 2026 at the 104.3 The Score studios located at Two Prudential Plaza, 180 N Stetson Avenue, Chicago, IL. 60601 from approximately 10:00am (CT) through 1:00pm (CT) (the “**Grand Prize Event**”). Each Qualifier will be allowed to bring up to one (1) guest (age 18 and up) with them to the Grand Prize Event.
10. Qualifiers must check-in with Station representatives at the Grand Prize Event between 9:30am (CT) and 10:00am (CT) and **MUST** remain present until the conclusion of the Grand Prize Event at approximately 1:00pm (CT). Qualifiers must present a valid government-issued photo ID and will be required to sign a liability release agreement and eligibility acknowledgement form “as-is” at check-in. Any guest of a Qualifier may be required to sign a liability release to enter. Any Qualifier who has not checked-in by 10:00am (CT), or who is not waiting in line to do so by 10:00am (CT), will be disqualified and that Qualifier’s opportunity to participate in any portion of the Grand Prize Event shall be forfeited. Upon completion of check-in, a Qualifier will be designated a “**Finalist**”, collectively, the “**Finalists**” in this Contest.
11. Once verified and properly checked-in, each Finalist will write their name on a slip of paper, provided by the Station and drop it into a designated prize box (the “**Prize Box**”) for the grand prize reverse drawing (as described in Section 12 below). Once completed, Qualifiers can take their seats in the Blue Cross Blue Shield Performance Stage area at The Score studios. At approximately 10:00am (CT), the Station will begin broadcasting live and the grand prize reverse drawing (as described in Section 12 below) will begin and continue through approximately 1:00pm (CT).
 - a. **FINALISTS MUST REMAIN AT THE GRAND PRIZE EVENT UNTIL THE OFFICIAL CONCLUSION OF THE GRAND PRIZE EVENT AT APPROXIMATELY 1:00pm (CT).**
 - b. Finalists will be given at least one (1) designated and announced ten (10) minute restroom break during the Grand Prize Event and live broadcast. 12. At approximately 10:00am (CT), the Station will begin a reverse drawing to select the Grand Prize Winner (as described in this Section 12 below) of this Contest. The reverse drawing will take place throughout the live broadcast and portions of the reverse drawing may be broadcast on-air. The reverse drawing may pause shortly from time to time throughout the Grand Prize Event. However, **ALL ELEMENTS** of the drawing will remain static and the same until the drawing resumes with selections. The reverse drawing will proceed by having a designated Station representative randomly draw one (1) slip of paper from the Prize Box and announce the name of the Finalist whose name appears on the paper. The Finalist whose name was announced will be disqualified. The reverse drawing will proceed in this manner, until only one (1) slip of paper remains in the Prize Box (the “**Final One**”). The Finalist whose name appears on the Final One will be designated as the “**Grand Prize Winner**”, and subject to verification of that Finalist’s eligibility and compliance with these Contest rules, will be eligible to receive the Grand Prize (as described in Section 17 below) in this Contest. In the event that the Finalist whose name appears on the Final One has been disqualified, then the Finalist whose name appeared on the slip of paper that immediately preceded the Final One, will be designated as the Grand Prize Winner, and subject to verification of that Finalist’s eligibility and compliance with these Contest rules, will be eligible to receive the Grand Prize (as described in Section 17 below) in this Contest.

ALL DECISIONS MADE BY STATION STAFF AND/OR MANAGEMENT ARE FINAL.**
16. The odds of becoming a Qualifier in this Contest depend on the number and placement of calls received at the time of each cue to call. The odds of winning the Grand Prize in this Contest will be no greater than 1:30.

Prize(s)

17. The one (1) verified Grand Prize Winner will receive the ten (10) suite tickets for the Cubs vs Athletics Major League Baseball game on Wednesday, June 3, 2026 at Wrigley Field, food and non-alcoholic beverages will be included, valued at approximately \$10,000.00 and courtesy of Audacy, (the, “**Grand Prize**”).
18. The Grand Prize Winner will be issued an IRS 1099 form by Audacy Illinois, LLC for the full amount of the value of the Grand Prize and such amount will be reported to the Internal Revenue Service for the 2026 tax year.
