

Secret Show Night 2, a Chick-fil-A Gift Basket, & More Contest Rules

These contest rules are specific to the above contest conducted by Audacy Washington d/b/a KKWF-FM (collectively the “**Station**”). Except to the extent specifically set forth below with respect to this specific contest, the Station’s general contest rules apply to this contest as well. How to Enter
