Contest Rules

These contest rules are specific to the above contest conducted by Audacy Wisconsin, LLC d/b/a WXSS-FM (collectively, the “**Station**”). Except to the extent specifically set forth below with respect to this specific contest, the Station’s general contest rules apply to this contest as well.
