

The Fan Golf Classic & Toyota Hole in One Contest OFFICIAL RULES

These Contest rules are specific to the above Contest conducted by Audacy Oregon, LLC. d/b/a KRSK-FM (the "Station"). Except to the extent specifically set forth below with respect to this specific Contest, the Station's general contest rules apply to this Contest as well. A copy of these specific Contest rules and the Station's general contest rules are available at the Station's studio at 1631 NW Thurman Ave, Suite 100, Portland, OR 97209 during regular business hours and on the Station's website at www.audacy.com/1051thefan. To the extent that the Station's general contest rules differ from these rules, these rules will govern and control with respect to this Contest.

THESE RULES DO NOT APPLY IN ANY MANNER TO THE GOLF TOURNAMENT ITSELF. **THESE RULES ONLY GOVERN THE HOLE-IN-ONE CONTEST AT THE TOURNAMENT.**

How to Enter/Eligibility

- 1. Tournament Date:** The Tournament and corresponding Hole in One Contest scheduled to occur on **June 23, 2026 at Langdon Farms Golf Club, 24388 Airport Road NE, Aurora, OR 97002** ("Tournament").
- 2. Who May Win:** The Hole in One Contest (the "**Contest**") described in these Contest rules can only be won by amateur golfers (*as defined by United States Golf Association USGA rules*) who are registered Tournament participants and are otherwise eligible under these rules and the general contest rules, except the following classes of people who are also ineligible to win:
 - Any touring professional, course professional, teaching professional, or any other professional or professional golfer as defined by USGA rules that have not been reinstated to amateur status, and/or
 - Employees (full and part time), officers, directors and agents of Station, Audacy, Million Dollar Media, Pacific Northwest Toyota Dealers Association, Toyota Motor Sales, U.S.A., Inc., or Langdon Farms Golf Club, or their affiliated companies, and those entities' advertising agencies (collectively, the "**Contest Entities**"), nor an individual domiciled with any such employee.
 - Participants in the Contest must be at least twenty-one (21) years old by the date of the Tournament, be an individual legally residing in the metropolitan area of Aurora, OR and must be a U.S. licensed driver.
- 3. How to Enter:** All officially registered participants in the Tournament are automatically entered into this Contest, except to the extent excluded or ineligible as described in Section 2 above (each a "**Contestant**"). Any participant who does not meet the eligibility requirements, or does not wish to participate in the Contest will be disqualified. Decisions of Tournament administrators and the Contest Administrator in connection with this Contest and regarding eligibility are final.

How to Win/Prizes

- 4.** The first eligible Contestant to make a properly witnessed Hole in One during the Tournament on hole 13 (the "**Grand Prize Hole**") will win the Grand Prize (*as described in Section 9 below*), subject to verification of eligibility and compliance with these Contest rules. **IN NO EVENT WILL MORE THAN ONE (1) GRAND PRIZE BE AWARDED IN THIS CONTEST. AS SOON AS THERE IS A GRAND PRIZE WINNER, THE GRAND PRIZE PORTION OF THIS CONTEST WILL IMMEDIATELY END.**
- 5.** The Grand Prize (as described in Section 9 below) **MAY** be awarded in the event of an eligible shot by a Contestant according to these rules:
 - All Hole in One shot attempts must occur from the minimum yardage listed below, regardless of tee box locations and must occur in the presence of the two (2) Station appointed hole witnesses for the Grand Prize Hole.

- Any Hole in One shot attempt from the wrong yardage or that is initiated without the presence of the designated hole witnesses on the Grand Prize Hole will be ineligible for any Grand Prize claim.

6. Eligible Hole in One Shot Requirements:

- Grand Prize Hole Witness Requirements** – All eligible Hole in One shot attempts on the Grand Prize Hole must be made in the presence of the two (2) Station appointed hole witnesses. Any shot initiated on the Grand Prize Hole without the presence of the hole witnesses for any reason, is ineligible for any Hole in One prize claim.
 - Yardage** – All Hole in One shots must occur from the minimum distance as listed above. Men and women must initiate their shot attempts from at least the minimum yardage listed above, regardless of the actual tee box locations on the golf course. Any shot attempts initiated from a closer distance, for men or women, will be invalid for any Hole in One prize claim regardless of the location of the actual tee boxes.
 - No Mulligans or Practice Shots** – There are no mulligans or practice attempts allowed on any prize hole. Only the first shot attempt as defined by USGA rules by each Contestant will be eligible for a Hole in One Grand Prize claim.
 - Maximum (1) Attempt** – Each Contestant may have a maximum of one (1) shot attempt per hole. Any Tournament Contestant who is ‘rounding out’ a 4-some is ineligible on their second shot attempt regardless of its outcome.
 - Golf Equipment** – All equipment used by Tournament Contestants must meet USGA specifications.
 - Eligible Hole in One** – In order to claim the Hole in One Grand Prize an eligible Contestant in the designated Tournament must make a Hole in One shot as defined by all USGA rules and guidelines and otherwise comply with the terms of this agreement.
- In the event of a successful Hole in One shot attempt, that eligible Tournament Contestant will be eligible to claim the Grand Prize, subject to verification of compliance with these Official Rules. A maximum of one (1) Hole in One Grand Prize will be awarded only to the first eligible Tournament Contestant who successfully completes a Hole in One shot on that particular hole according to the requirements as outlined in these rules.
 - If there is not an eligible Hole in One shot attempt by an eligible Tournament Contestant on the Grand Prize hole, then no prizes will be awarded in this Contest.
 - Hole #13 Prize (if won) is one (1) 2026 Toyota Corolla SE (“Grand Prize”), valued at up to, but in no event to exceed \$10,064.94 and subject to the following (“Grand Prize”):**
 - The Grand Prize must be accepted by the Grand Prize Winner “as-is”. The Grand Prize will be delivered solely with the express written limited warranties set forth in the Grand Prize’s applicable Owner’s Guide, which warranties shall run for the term set forth in said Guide;
 - The depiction of the Grand Prize in any advertising or promotional materials or physical display may not reflect the actual Grand Prize delivered to the Grand Prize Winner.
 - The Grand Prize Winner must be well qualified and approved by Toyota Financial Services. The Grand Prize Winner will be responsible for any additional fees that may apply if Grand Prize Winner does not meet credit requirements.
 - Prior to being provided with possession of the Grand Prize, the Grand Prize Winner must pay title, license and registration fees to be determined by Grand Prize Winner’s postal code.
 - Grand Prize has no cash value, cash may not be substituted for vehicle is not assignable to transferable to any other person.
 - Grand Prize Winner shall be solely responsible for obtaining and payment of any federal or state required registration, inspection, emissions inspection, insurance coverage, federal taxes,

- gasoline, Grand Prize maintenance (including routine oil changes and tire rotations), excessive wear and tear, and all other fees and expenses associated with the receipt and use of the Grand Prize.
- g. Prize Provider shall not be responsible for delays in making the Grand Prize available for pick up at Dealer, which timing shall be subject to availability. Prize Provider, however, shall use all reasonable efforts, subject to availability, to make the Grand Prize available for pick up within one hundred eighty (180) days after receipt of the aforementioned items/information. The Grand Prize Winner shall bear all risk of loss or damage to the Grand Prize after it has been delivered to the specified delivery site.
 - h. The Grand Prize Winner must personally retrieve/pick up the Grand Prize within thirty (30) days of written notification of delivery and must present adequate personal identification and evidence of legally required insurance (or an alternative Grand Prize Winner shall be selected and the original Grand Prize Winner's rights to the Grand Prize shall be automatically forfeited).
 - i. Grand Prize Winner will be required to complete all relevant documents and to pick up the Grand Prize at Dealer during regular business hours and completed all necessary paperwork on a date/time mutually agreed to by the winner and Dealer, but the Grand Prize must be picked up within thirty (30) days following winning or whenever the Grand Prize Winner's Grand Prize becomes available. FAILURE TO PICK UP THE GRAND PRIZE, COMPLETE ALL OF THE REQUIRED FORMS AND PAY ALL ADVANCE FEES REQUIRED WITHIN THIRTY (30) DAYS OF WINNING, FOR ANY REASON WILL AUTOMATICALLY RESULT IN FORFEITURE OF ANY PRIZE IN THIS CONTEST BY THE WINNER. Station is NOT obligated to select a replacement Grand Prize Winner (but reserves the right to do so in its sole discretion, time permitting).
 - j. Any damage to the Grand Prize will be the sole responsibility of the Grand Prize Winner.
 - k. Acceptance of a prize constitutes permission for Manager and Prize Provider and/or their designees to use the Grand Prize Winner's name, address, photograph, testimonial or other likeness and/or prize information or personal exposition (and/or any edited portion thereof) for promotional, advertising and/or publicity purposes in any media, now or hereafter known throughout the world in perpetuity, without compensation or notice to, or further consent of, to the Grand Prize Winner to the extent permitted by law.
 - l. The Contest Entities shall not have any responsibility or liability whatsoever for any property loss, damage, personal injury, or death, in connection with the prizes provided pursuant to the Contest and/or any person's participation in the Contest; provided, however, that Prize Provider shall be solely responsible for any express written limited warranties specifically set forth in the applicable Owner's Guide for the Grand Prize.
10. The transfer of possession of the Grand Prize to the Grand Prize Winner shall be at no cost to the Grand Prize Winner (other than required title, license and registration set forth in Section 9 above) and there shall be no other charge for freight, handling, doc fees nor any other fees or charges.
11. No person shall be entitled to any prize in this Contest unless he/she complies with all of the requirements of these rules (including the applicable general contest rules) and Station confirms his/her eligibility and compliance with these rules. In addition, with respect to any potential Grand Prize Hole in One winner of the Grand Prize, the potential Grand Prize Winner must also provide Station with the following:
- a. **Within three (3) business days of winning:**
 - i. Their name, address, phone number, social security number, and photocopy of a government issued photo identification card;
 - ii. An original affidavit completed;
 - iii. An IRS W-9 Completed and signed by the winner.
 - b. Upon Station's request, but only prior to the delivery of the prize, recorded statements may be required from the winner and/or playing partners to verify compliance with all material terms and conditions.
12. Failure to collect or properly claim any prize in accordance with these rules will result in forfeiture of the prize. If forfeited for any reason, potential winner will not receive any other prize substitution or compensation.

Other Rules Specific to this Contest

13. **IN CASE OF DISPUTES:** By participating, each entrant agrees that (1) any and all disputes, claims, and causes of action arising out of or in connection with this Promotion, or any prizes awarded, shall be resolved individually, without resort to any form of class action, and any judicial proceeding shall take place in a federal or state court within the State of New Jersey; (2) any and all claims, judgments, and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this Promotion, but in no event attorneys' fees; and (3) under no circumstances will entrant be permitted to obtain awards for, and entrant hereby waives all rights to claim, punitive, incidental, and consequential damages, and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of entrant and Sponsor in connection with this Promotion, shall be governed by, and construed in accordance with the laws of the State of New Jersey, without giving effect to any choice of law or conflict of law rules or provisions (whether of the State of New Jersey or any other jurisdiction), that would cause the application of the laws of any jurisdiction other than the State of New Jersey.
14. **Odds:** The odds of successfully hitting a Hole in One are dependent upon the skill of the Tournament Contestant.
