

## Living On A Red Flag – AUDIO CONTEST Contest Rules

These contest rules are specific to the above contest conducted by Audacy Massachusetts, LLC d/b/a WBMX(FM) (collectively, the “**Station**”). Except to the extent specifically set forth below with respect to this specific contest, the Station’s general contest rules apply to this contest as well. A copy of these specific contest rules and the Station’s general contest rules are available at the Station’s studio at 10 Guest Street, Floor 3, Boston, MA 02135 during regular business hours and on the Station’s website at [www.mix1041.com/rules](http://www.mix1041.com/rules). **To the extent that the general contest rules differ from these rules, these rules will govern and control with respect to this contest.**

### How to Enter

---

1. No purchase or payment of any kind is necessary to enter or win the Living On A Red Flag contest (the “**Contest**”). A purchase or payment will not increase your chance of winning.
2. To enter this Contest, you must be 18 years of age or older as of the date of entry.
3. To enter, from Monday, June 29, 2026 at 12:00am (ET) through 4:00pm (ET) on Thursday, July 9, 2026, go to [www.mix1041.com](http://www.mix1041.com), click on the Living On A Red Flag link and complete the on-line entry form with:
  - a. your contact information (name, address, daytime telephone number, email address) (“**Entrant**”);
  - b. upload an audio file about what red flag you ignored in a relationship. Audio file should not exceed thirty (30) seconds (longer audio files will not be disqualified but Station judges will only listen to the first thirty (30) seconds of each entry and only the first thirty (30) seconds will be posted online, if applicable). The uploaded audio must be in one of the following audio formats: .mp3 / .wav *Max file size = 30 MB*
4. **Only the individual who submits the entry can be heard in the audio.** No other person’s image, voice or talent can be captured in the audio. **Any audio with any other person(s) or more than one person heard in it will be ineligible and will be disqualified. ANY AUDIO THAT CONTAINS ANY MUSIC WHATSOEVER WILL BE IMMEDIATELY DISQUALIFIED. Entrants may not even sing or speak the lyrics to any copyrighted song or any other copyrighted material in their audio (no portion of copyrighted poems, etc.) unless the associated copyrights are owned by the Entrant and no one else (Station may require proof).**
5. All Entrants who submit an entry agree to the following and Station will require, as a condition of entry, that entrants affirmatively check a box or an “I agree” button expressly confirming the following:
  - Entrant represents and warrants that he/she is over 18 years of age and a legal resident of the state(s) of: Connecticut, Massachusetts, New Hampshire, or Rhode Island.
  - Entrant represents and warrants that he/she own the rights to, or have obtained permission to use, the audio submitted with the entry.
  - Entrant represents and warrants that there is only one person heard in the attached audio and that person is the Entrant.
  - Entrant represents and warrants that he/she authorizes Station to post the audio on Station’s website or social network sites or use the audio in any other way Station sees fit.
  - Entrant agrees and acknowledges that Station and Contest sponsors and their respective affiliates, parents, employees, agents and all other related sponsors may use for advertising and/or promotional purposes, Entrant’s name, image, audio submission, other entry materials and/or biographical information on radio, TV broadcasts, newspaper advertisements, on websites and/or any other medium in connection with participation in this Contest or otherwise without the payment of any additional compensation.
  - Entrant understands and agrees that Station shall be the sole and exclusive owner of the audio submitted, whether or not the audio is selected as a winner, and Entrant agrees to sign any documents requested by Station to evidence such transfer of ownership.

6. **By entering this Contest the Entrant consents to use of the audio (in whole or in part) by Station in any manner it sees fit with no compensation to the Entrant. By submitting audio, each Entrant represents and warrants that they own the rights to, or have obtained permission to use, the audio submitted with each entry. Further, each Entrant authorizes the Station to post the audio on the [www.mix1041.com](http://www.mix1041.com) website or its Facebook page or other social media sites.**
7. Audio entries must not contain any indecency, profanity or obscenity as determined by Station in its sole discretion. Audio entries must not contain or depict any registered trade/servicemark or other copyrighted material other than those owned or licensed by the Entrants or the Station or a Contest Sponsor. BY ENTERING THIS CONTEST AND SUBMITTING AUDIO, THE ENTRANT IS REPRESENTING TO STATION THAT THE USE AND DISTRIBUTION OF SUCH AUDIO WILL NOT VIOLATE OR INFRINGE UPON THE RIGHTS OF ANY THIRD PARTY, INCLUDING, WITHOUT LIMITATION, COPYRIGHTS OF OTHERS. By submitting audio, Entrants agree to indemnify Station should any representations and warranties in these Contest rules prove to be false or inaccurate.
8. **By entering this Contest, Entrants understand and agree that Station may elect to use any entry submitted for entertainment purposes and may choose to comment on, mock, poke fun at, and/or mimic any entry submitted. Entrants waive any right to make any claim against Station or any Contest sponsors with respect to any comments - disparaging or otherwise - made regarding such Entrant's entry.**

#### **How to Win**

9. Beginning at approximately 12:00pm (ET) on June 29, 2026 through 4:00pm (ET) on Thursday, July 9, 2026, Station will post some or all eligible entries on the Station website so that listeners and website visitors may listen to the entries. Station decision to publish any eligible entry on the website shall in no way be construed as an indication that such entry has been or will be selected as a potential winning entry in this Contest.
10. On or about 4:00pm (ET) each weekday starting on Thursday, July 2, 2026 through Thursday, July 9, 2026 (**excluding Friday, July 3, 2026**), Station staff and/or management will select one (1) winner per day (subject to eligibility verification and compliance with these Contest rules), from among all eligible entries received through the time of such selection as the audio that Station judges deem the best based on any lawful criteria as determined by the Station in its sole discretion.
11. The Station will announce the name of a potential winner each weekday between 7:00am (ET) and 9:00am (ET) starting Monday, July 6, 2026 through Friday, July 10, 2026. A potential winner need not be listening in order to win, but being announced on-air does not in any way guarantee any prize to an otherwise ineligible entrant. Station will contact a potential winner by means of the phone number and/or email address provided with entry. Should a potential winner not meet the eligibility requirements or is disqualified for any other reason, Station may select (but shall not be obligated to select) an alternate winner.
12. There will be up to, but in no event more than, one (1) winner each day, for a total of up to, but not more than, five (5) winners in this Contest.
13. An individual may only win one (1) time in this Contest.



14. The odds of winning a prize in this Contest depend upon the number of entries received and the subjective opinion of the Judges.

### **Prize(s)**

The up to five (5) verified Winners in this Contest will each receive: two (2) tickets to see Bon Jovi in concert on Sunday, July 19, 2026 at Madison Square Garden located at 4 Pennsylvania Plaza, New York, NY 10001, valued at \$150.00, courtesy of Live Nation (the, "**Prize**"). Ground transportation, hotel accommodations, and incidentals are NOT included in the Prize.
