

**WBEB(FM) Free Gas for Life – or as far as \$50,000 will take you
BANK VAULT CONTEST
OFFICIAL RULES**

These contest rules are specific to the above contest conducted by Audacy Pennsylvania, LLC d/b/a WBEB(FM) (the “**Station**”). Except to the extent specifically set forth below with respect to this specific contest, the Station’s general contest rules apply to this contest as well. A copy of these specific contest rules and the Station’s general contest rules are available on the Station’s website at www.b101philly.com/rules. **To the extent that the Station’s general contest rules differ from these rules, these rules will govern and control with respect to this contest.**

How to Enter

1. No purchase or payment of any kind is necessary to enter or win the WBEB(FM) Free Gas for Life – or as far as \$50,000 will take you Contest (the “**Contest**”). A purchase will not increase your chances of winning.
2. To enter you must be eighteen (18) years of age or older as of the date of entry in order to win any prize in this Contest and must be a legal resident of Pennsylvania, New Jersey or Delaware. Employees of Audacy Pennsylvania, LLC, Million Dollar Media, or any other sponsors participating in this Contest, and their respective affiliated companies, advertising or promotional agencies (collectively with Station, “**Sponsors**”) and the immediate family and household members of each are ineligible to participate in this Contest (i.e., spouses, parents, grandparents, children, grandchildren, cohabitating partners, roommates, and siblings). Despite the designation above in the definition of “Sponsor”, Million Dollar Media, is not a party to this Contest or the conduct of this Contest.
3. Prior to the start of the Contest, a predetermined four (4) digit combination will be randomly pre-selected for this Contest by Million Dollar Media (“**MDM**”), and placed in a sealed security envelope provided to the Station (the “**Winning Combination**”). The Winning Combination will be programmed into the keypad and locking mechanism of the designated “**Bank Vault**” that will be used for all Contest attempts.
 - a. **The Winning Combination shall be comprised of four (4) digits, each a single-digit whole number between zero (0) and nine (9) inclusive (i.e., no one of the four digits will be a fraction, a decimal, or a whole number with a value greater than nine).**
 - b. **The same digits may be used more than once within the Winning Combination (i.e., the predetermined Winning Combination could be 1-1-1-1).**
4. Starting on Monday, July 6, 2026 through the sooner of either Friday August 14, 2026 or the point at which the one (1) Grand Prize (*as described in Section 11 below*) has been awarded in this Contest, listen to the Station each weekday (*Monday-Friday only, excluding weekends*) between 8:00am (ET) and 9:00am (ET) (each, a “**Contest Day**”) for the Station announcement of the cue to call. Caller ten (10) to the Station’s contest line at (888) 333-2101 at the time of the cue to call, upon verification of eligibility and compliance with these Contest Rules (each, a “**Qualifier**” and collectively, “**Qualifiers**”), will get one (1) opportunity to correctly guess the Winning Combination to win the Grand Prize (*as described in Section 11*) (each, a “**Contest Play**”). Each potential Qualifier will be required to provide and/or confirm the following information before they are entitled to participate further in the Contest:
 - a. Full legal name, address and phone number
 - b. Confirm that they are eighteen (18) years of age or older
 - c. Confirm that they are a legal Pennsylvania, New Jersey or Delaware resident as of the entry date
 - d. Confirm that they and none of their immediate family (i.e., current and ex-spouses, parents, grandparents, children, grandchildren, and siblings and in-laws and steps in any of the foregoing categories) and other household members (i.e., roommates, housemates, significant others, and partners of each legally residing at the same address) are NOT full-time, part-time or temporary employees of Audacy or Million Dollar Media or their parent entities, subsidiaries, affiliated companies, advertising or promotion agencies

- e. Confirm that they are in possession of the following documents and can provide copies to Station immediately upon request: (i) valid U.S driver's license or government issued photo ID card; and (ii) valid social security card

If the potential Qualifier is unable to promptly provide or confirm (as applicable) ALL of the above requirements to Station's reasonable satisfaction, Station reserves the right to immediately disqualify that potential Qualifier (which decision by Station shall be final and not appealable) and Station will then select an alternate caller by taking the immediate next caller waiting on the phone line and repeat the process until these requirements have been satisfied and a verified Qualifier is found. Each verified Qualifier will receive one (1) Qualifying Prize (*as described in Section 10 below*). Only verified Qualifiers are entitled to a Qualifying Prize in this Contest.

- b. **IMPORTANT! Only calls received to the studio contest phone number above are eligible to win (calls to the main radio station phone number or any other phone numbers are not acceptable).**
- c. Station is not responsible for telephone service outages, delays, busy signals, equipment malfunctions, or any other technological difficulties that may prevent an individual from completing his or her telephone call.
- d. Decisions by the Station on potential Qualifiers's eligibility, and all matters related to this Contest are final.
- e. **You may only be a verified Qualifier once in this Contest.**

How to Win

5. For Contest Plays with successfully verified Qualifiers, the Contest will proceed as follows: Each verified Qualifier will have up to approximately twenty (20) seconds, as determined by Station in its sole discretion, to make his or her guess of the four (4) digit Winning Combination to the Bank Vault. The Station will record the Qualifier's four (4) digit combination guess in the official Contest Registration Binder (the "**Contest Registration Binder**") and enter it exactly as recorded into the keypad and locking mechanism of the designated Bank Vault provided to Station by MDM. In order for a Contestant to win the Grand Prize (*as described in Section 11 below*):
 - a. The Qualifier's Winning Combination guess as recorded on air and in the official Contest Registration Binder must match, in exact order, the predetermined Winning Combination selected by MDM, as placed in the sealed security envelope **AND** preprogrammed into the Bank Vault (*as described in Section 3 above*);
 - b. The Qualifier's number guess must trigger the locking mechanism and open the Bank Vault only by means of entering that Winning Combination four (4) digit number into the keypad on the Bank Vault.
 - c. **HOWEVER, THE ACT OF OPENING THE BANK VAULT DOOR ALONE DOES NOT CONSTITUTE A WINNING COMBINATION ATTEMPT. The Grand Prize (*as described in Section 11 below*) will NOT be awarded as a result of any of the following:**
 - i. **Any Qualifier's Winning Combination guess as recorded by the Station in the official Contest Registration Binder and entered into the digital keypad on the Bank Vault does not match the predetermined Winning Combination contained in the sealed master envelope;**
 - ii. **Any tampering, malfunction, damage, or use of physical force that causes the Bank Vault to unlock or open;**
 - iii. **Any Qualifier's Winning Combination guess that the Station records a Winning Combination in the Contest Registration Binder, but fails to correctly enter the same four (4) digit combination into the keypad.**
 - d. **Station will only accept the first guess of each numeric digit until there are four (4) digits guessed in total.**

6. **IN THE EVENT THAT THE BANK VAULT OPENS FOR ANY REASON, CORRECTLY OR INCORRECTLY, THIS CONTEST WILL IMMEDIATELY END, WITH OR WITHOUT A GRAND PRIZE WINNER, AND NO FURTHER QUALIFIERS WILL HAVE ANY RIGHT TO ATTEMPT TO OPEN THE BANK VAULT. IF THE BANK VAULT OPENS INCORRECTLY, STATION RESERVES THE RIGHT TO CONTINUE THE CONTEST UNDER NEW CONTEST RULES AFTER THE BANK VAULT HAS BEEN SATISFACTORILY REPAIRED.**
7. **IN THE EVENT THAT THERE ARE THIRTY (30) ATTEMPTS AND THERE IS NO GRAND PRIZE WINNER, THIS CONTEST WILL IMMEDIATELY END, WITH OR WITHOUT A GRAND PRIZE WINNER, AND NO FURTHER QUALIFIERS WILL HAVE THE OPPORTUNITY TO ATTEMPT TO OPEN THE BANK VAULT.**
8. **By participating in the Contest, Qualifiers agree not to hold Station liable for any accidental human error in the recording of the Qualifier's Winning Combination guess in the Contest Registration Binder, or in entering the Qualifier's Winning Combination guess into the Bank Vault keypad.**
9. The odds of winning a qualifying prize in this Contest depend upon the number of calls received to the Station's contest line at the time of the Contest Play. The approximate odds of a verified Qualifier winning the grand prize in this Contest are 1:10,000.

Prize(s)

10. **QUALIFYING PRIZE:** Each of the up to thirty (30) verified Qualifiers in this Contest will receive one (1) \$101.00 Visa Debit Gift Card. Gift card is accepted anywhere Visa debit cards are accepted. The card is valid for use until the funds have been exhausted or until the card has expired (36-month expiration date from date of purchase) (the, "**Qualifying Prize**"). The gift card will be mailed to verified Qualifiers within thirty (30) days from the date upon which the Qualifier completes and returns all Station required documents.
11. **GRAND PRIZE:** In the event a verified Qualifier successfully guesses the Winning Combination to the Bank Vault, upon satisfaction of all circumstances described in these Contest rules and upon verification of eligibility by Station and Million Dollar Media (the "**Grand Prize Winner**"), the verified Grand Prize winner will receive \$50,000.00, awarded in the form of a company check from Million Dollar Media made payable to such Grand Prize Winner only (the, "**Grand Prize**"). **A maximum of one (1) Grand Prize will be awarded (if at all).**
12. In addition to verification of eligibility, any potential Grand Prize Winner shall not be entitled to any prize in this Contest unless he/she provides Station with legible copies of the following within five (5) business days of winning:
 - a. **Qualifier Information:** Full legal name, address, phone number and photocopy of a US federal or state government issued photo identification card of the actual person/winner who completed the prize winning requirements; and valid social security card
 - b. **W-9 Form:** Completed and signed by the winner
 - c. **Affidavits:** Execution of all affidavits of eligibility and/or liability release agreements required by Station
 - d. **Failure to comply with the foregoing requirements for any reason within five (5) business days of winning will result in automatic forfeiture of the Grand Prize in this Contest and disqualification of such potential Grand Prize Winner.**
13. The Grand Prize will be awarded to the verified Grand Prize Winner within approximately 6 to 8 weeks of receipt of all required prize acceptance paperwork. Station will contact Grand Prize Winner by phone at the phone number provided to Station when the Grand Prize check is available to be picked up. Station will only be required to leave one (1) message at the telephone number provided by Grand Prize Winner to Station. Station shall have no responsibility for any technical failures of answering machine. **IF THE**

GRAND PRIZE WINNER DOES NOT CLAIM THEIR GRAND PRIZE WITHIN SIXTY (60) DAYS AFTER NOTIFICATION OF PICKUP, HE OR SHE WILL BE AUTOMATICALLY DISQUALIFIED. IN SUCH EVENT, THE GRAND PRIZE WILL NOT BE AWARDED AND WILL REMAIN THE PROPERTY OF STATION.
