

Beat Mercedes - Week of July 27, 2026

Contest Rules

These Contest rules are specific to the above Contest conducted by Audacy Nevada, LLC d/b/a KMXB-FM (collectively, the “**Station**”). Except to the extent specifically set forth below with respect to this specific Contest, the Station’s general contest rules apply to this Contest as well. A copy of these specific Contest rules and the Station’s general contest rules are available on the Station’s website at mix941fm.radio.com/rules. **To the extent the general contest rules differ from these rules, these rules will govern and control with respect to this contest.**

Entry/Winning

1. NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THE “BEAT MERCEDES - Diana Ross - 10.02.2026 ON-AIR CONTEST” (the “**Contest**”).
2. To enter, listen to the station weekdays (Mon-Fri) beginning on Monday, July 27, 2026 through Friday, July 31, 2026 at approximately 7:00am (PT) for the cue to call from the on-air personality (each, a “**Contest Play**”). Notwithstanding the foregoing, Station reserves the right not to conduct (skip) this contest on any particular weekday in its sole discretion. After the Contest Play airs on the Station, the 20th caller to get through to the Station at 702-364-9400 (each, a “**Contestant**”) will be given a chance to play “Beat Mercedes”. Mercedes will leave the studio, and the Contestant will be played a snippet of a song. The Contestant will have to correctly guess the song title and artist name as quickly as they can. The Contestant will be timed from when the snippet begins to play until when they correctly guess the song title and artist name. If the Contestant incorrectly guesses either the song title or the artist name, they will be disqualified, no prize will be awarded for that Contest Play. Should a contestant correctly guess the song title and artist name of the selected snippet, Mercedes will be brought back into the studio and will also be given a chance to correctly guess the song title and artist name of the selected song snippet. Mercedes will also be timed starting from when the song snippet begins to play until she correctly guesses the song title and artist name. If Mercedes correctly guesses both the song title and artist name in a time faster than the selected Contestant, that Contestant will not win a prize. If Mercedes incorrectly guesses either the song title or the artist name, or correctly guesses the song title and artist name in a time slower than the selected Contestant, that selected Contestant, will, upon verification of eligibility and compliance with these Contest Rules, receive a Prize (*as described in Section 5 below*) (each, a “**Winner**”)
 - a. Each Contestant and Mercedes will only get to listen to a maximum of twenty (20) seconds of the selected song.
 - b. A Station judge who knows the correct answer to the song title and artist name will be the SOLE determiner of whether a guess is correct or not. This decision is not appealable.
 - c. Each song snippet will be predetermined by the Station prior to each Contest Play.
 - d. In the event that the selected caller is not able to correctly guess the song title or artist, a cue to call will then be announced. The 20th caller to get through to the Station at 702-364-9400, subject to verification of eligibility and compliance with these Contest Rules, will become a Prize Winner.
 - e. **WARNING: ONLINE LISTENERS TO STREAMED BROADCASTS MAY EXPERIENCE A LAG IN TRANSMISSIONS DUE TO BUFFERING LIMITATIONS. CONTEST PARTICIPANTS SHOULD NOT RELY ON STREAMED BROADCASTS.**

f. CALLS TO OTHER NUMBERS, OTHER THAN THE ANNOUNCED NUMBERS, INCLUDING THE STATION'S GENERAL NUMBER, WILL NOT BE ACCEPTED.

3. There will be up to, but in no event more than, Five (5) verified Winners in this Contest.
4. Odds of becoming a Contestant depend upon the number of calls received for any particular Contest Play. Odds of a Contestant winning a Prize depend on the song knowledge of each Contestant.
