

WNEW-FM \$102K Summer of Styles Contest Rules

These Contest rules are specific to the above Contest conducted by Audacy New York, LLC d/b/a WNEW-FM (collectively, the “**Station**”). Except to the extent specifically set forth below with respect to this specific Contest, the Station’s general contest rules apply to this Contest as well. A copy of these specific Contest rules and the Station’s general contest rules are available on the Station’s website at www.new1027.com/rules. To the extent that the general contest rules differ from these rules, these rules will govern and control with respect to this Contest.

How to Enter

1. No purchase or payment of any kind is necessary to enter or win the WNEW-FM \$102K Summer of Styles contest (the “**Contest**”). A purchase will not increase your chances of winning.
2. To enter you must be eighteen (18) years of age or older as of the date of entry in order to win any prize in this Contest and must be a resident of New York, New Jersey, or Connecticut. Employees of Audacy New York, LLC, Million Dollar Media, Live Nation, Columbia Records, or any other sponsors participating in this Contest location, and their respective affiliated companies, advertising or promotional agencies (collectively with Station, “**Sponsors**”) and the immediate family and household members of each are ineligible to participate in this Contest (i.e., spouses, parents, grandparents, children, grandchildren, co-habituating partners, roommates, and siblings). Despite the designation above in the definition of “Sponsor”, Million Dollar Media, is not a party to this Contest or the conduct of this Contest.
3. To be eligible for the Grand Prize (as described in Section 24 below), must be present on Tuesday, September 1, 2026 at the WNEW-FM studios, located at 345 Hudson Street, New York, NY 10014, between the times to be determined by the Station for check-in with the prize attempts commencing at approximately 5:30pm (ET) (the “**Grand Prize Event**”).
4. There are two (2) ways to enter this Contest:
 - a. **On-Air Method of Entry** – Listen to the Station each weekday (Monday – Friday) starting on Monday, July 27, 2026 and ending on Friday, August 28, 2026 at approximately 7:40am (ET) for the Station to announce a designated “Summer of Styles Song of the Day”(the “**Song**”) , a different Song will be announced each day. Once the Song has been announced for that day, you may enter by listening for that day’s Song to play sometime before 6:00pm (ET) the same day (each, a “**Song Play**”). Upon hearing the Song played in its entirety, be the 10th caller to 1-800-949-1027, and upon verification of eligibility and compliance with these Contest rules, becomes an “**On-Air Qualifier**”, receives one (1) Qualifying Prize (as described in Section 21 below) and will get the opportunity to participate in the Grand Prize Event for the chance to win the Grand Prize (as described in Section 24 below). At the time of the designated caller’s selection, the designated caller will be required to provide all information requested including their full name, complete address (including zip code), day and evening phone numbers, email and date of birth, and they must confirm their availability to attend the Grand Prize Event on Tuesday, September 1, 2026 in order to be eligible to win. Any entrant who does not meet the eligibility requirements or who is unable or unwilling to attend the Grand Prize Event on Tuesday, September 1, 2026 will be disqualified, will not become an On-Air Qualifier, and will not be entitled to any prize in this Contest. In the event that the designated caller is disconnected or is found to be ineligible, the next caller who successfully makes it through on the Station contest

line and is eligible, will be an On-Air Qualifier. This process will continue until an On-Air Qualifier is found.

- i. A PERSON MAY BECOME AN ON-AIR QUALIFIER ONLY ONCE IN THIS CONTEST.
 - ii. There will be a minimum of one (1) Song Play a weekday, but from time to time the Station may elect, but is not obligated to, conduct more than one (1) Song Play a weekday. However, there will be no more than a maximum of thirty-one (31) Song Plays in this Contest.
 - iii. Only calls received to the studio contest phone number above are eligible to win (calls to the main radio station phone number or any other phone numbers are not acceptable).
 - iv. Station is not responsible for telephone service outages, delays, busy signals, equipment malfunctions or any other technological difficulties that may prevent an individual from completing his or her telephone call
 - v. Decisions by the Station on an entrant's eligibility, and all matters related to this Contest are final.
 - vi. **WARNING! ONLINE LISTENERS TO STREAMED BROADCASTS MAY EXPERIENCE A LAG IN TRANSMISSIONS DUE TO BUFFERING LIMITATIONS. CONTEST PARTICIPANTS SHOULD NOT RELY ON STREAMED BROADCASTS.**
- b. **Online Method of Entry** – To enter from approximately 12:00am (ET) on Monday, July 27, 2026 through approximately 11:59pm (ET) on Sunday, August 30, 2026, go to www.new1027.com/contests, click the "\$102K Summer of Styles" Contest entry graphic/link, complete the online registration form with all required information including entrant's name, complete address (including city, state and zip), valid email address, age, and phone number(s) (including area code(s)), and then click submit.

On or about Monday, August 31, 2026 at approximately 10:00am (ET), up to one (1) entry will be randomly selected from among all eligible entries received through the Online Method of Entry and upon verification of eligibility and compliance with these Contest rules, will become an **"Online Qualifier"**, receive one (1) Qualifying Prize (as described in Section 21 below) and will get the opportunity to participate in the Grand Prize Event for the chance to win the Grand Prize (as described in Section 24 below).

The potential Online Qualifier will be notified within one (1) hour of being selected via telephone at the number such entrant provided when completing their online entry to this Contest. Station is only required to place one (1) phone call. Notification is deemed to have occurred immediately at the time the Station communicates such notification. Station reserves the right, but not the obligation, to attempt to contact the potential Online Qualifier more than once via telephone, in its sole and absolute discretion, and will not be required to attempt to contact any potential Online Qualifiers an equal number of times or in the same manner. If the potential Online Qualifier cannot be contacted, or if Station does not receive a response from the potential Online Qualifier within three (3) hours of notification of selection from Station, then the potential Online Qualifier will be disqualified. At the time of verification, the potential Online Qualifier will be required to provide all information requested including their full name, complete address (including zip code), day and evening phone numbers, email and date of birth, and they must confirm their availability to attend the Grand Prize Event on Tuesday, September 1, 2026 in order to be eligible to win. Any entrant who does not meet the eligibility requirements or who is unable or unwilling to attend the Grand Prize Event on Tuesday, September 1, 2026 will be disqualified, will not become an Online Qualifier, and will not be entitled to any prize in this Contest. If the

potential Online Qualifier does not complete and submit all documents required by the Station before the designated deadline communicated to the potential Online Qualifier at the time of verification, then the potential Online Qualifier will be disqualified. In the event that the potential Online Qualifier is disqualified, the Station has the right, but not the obligation, in its sole discretion, to select an alternate potential Online Qualifier in a random drawing of all remaining eligible online entries received

- i. A person may enter via this Online Method of Entry an unlimited number of times during the online entry period.
 - ii. Accepting any available opt-in opportunities from our sponsors and/or Station is not required to enter the Contest, and checking the opt-in boxes will not improve your chances of winning. Entrants may opt-out of any further email communication at any time without affecting their entry by following the provided opt-out instructions, or replying REMOVE to any email message.
 - iii. In the event of a dispute as to any on-line registration, the authorized account holder of the e-mail address used to register will be deemed to be the registrant and he/she must be eligible according to these Contest rules. The "authorized account holder" is the natural person assigned an e-mail address by an Internet access provider, online service provider or other organization responsible for assigning e-mail addresses for the domain associated with the submitted address.
5. There will be up to but in no event more than thirty-one (31) On-Air Qualifiers and one (1) Online Qualifier in this Contest (collectively, the **"Qualifiers"**).
6. **NO MATTER THE METHOD OF ENTRY, A PERSON MAY ONLY QUALIFY ONCE IN THIS CONTEST AND MAY ONLY OBTAIN ONE (1) QUALIFIER SPOT IN THE GRAND PRIZE EVENT. ONCE A PERSON QUALIFIES, NO MATTER THE METHOD OF ENTRY, THEY MAY NOT ENTER OR QUALIFY AGAIN IN THIS CONTEST.**
7. The up to thirty-two (32) Qualifiers must be present for the Grand Prize Event on Tuesday, September 1, 2026. Any Qualifier who fails to appear for the Grand Prize Event will be disqualified, and will not receive any alternate attempts, participation, prize award, prize substitution or compensation of any kind. The Station reserves the right in its sole discretion to change the date, time or location of the Grand Prize Event. Qualifiers will be notified of any changes at the time of their selection and/or notification. **Difficulties with getting to location to enter or participate in the Contest are not the responsibility of Station/Sponsor.**
8. By entering this Contest, all Entrants acknowledge that by their participation in this Contest they hereby grant and provide their consent to being videotaped before, during and after the Contest and Grand Prize Event (including, without limitation, signing required forms) in association with this Contest

How to Win

9. IN ORDER TO PARTICIPATE IN THE GRAND PRIZE EVENT, QUALIFIERS MUST BE PRESENT ON TUESDAY, SEPTEMBER 1, 2026 AT THE WNEW-FM STUDIOS, LOCATED AT 345 HUDSON STREET, NEW YORK, NY 10014, BETWEEN THE TIMES TO BE DETERMINED BY THE STATION FOR CHECK-IN WITH THE PRIZE ATTEMPTS COMMENCING AT APPROXIMATELY 5:30PM (ET). The Station will notify all Qualifiers using the phone number and/or email address provided to the Station by each such Qualifier of the specific check-in time of the Grand Prize Event

as soon as those details are finalized, but in no event later than Monday, August 31, 2026 . Station will only be required to notify each Qualifier one (1) time of the specific time of the Grand Prize Event check-in. In the event the Station cannot contact a Qualifier, the Station will only be required to leave one (1) voicemail and/or send one (1) email, as applicable, with the specific time of the Grand Prize Event check-in. In no event will Station or Sponsors have any liability or responsibility for the failure of any Qualifier to receive any voicemail and/or email for any reason, and/or for the inability of any Qualifier to attend the Grand Prize Event.

10. Qualifiers must check in with Station staff at the Grand Prize Event between the times communicated to the Qualifier by the Station in order to be eligible for a chance to win the Grand Prize. Qualifiers must present a valid government-issued photo ID and will be required to sign a liability release agreement and eligibility acknowledgement form “as-is” at check-in. Any Qualifiers who have not checked-in by the deadline as communicated by the Station, or who are not waiting in line to do so by such deadline, will be disqualified, and such Qualifier’s opportunity to participate in any portion of the Grand Prize Event shall be forfeited. Any Qualifier who refuses to sign the Station’s liability release agreement and acknowledgement form “as is” at check-in will be disqualified and will forfeit their opportunity to participate in the Grand Prize Event.
11. At the time of check-in, each Qualifier will be assigned a number corresponding to the order in which they have completed their check-in starting with number 1 for the first Qualifier who completes check-in. All Qualifiers who are properly and timely checked in will have an opportunity to participate in the Grand Prize Event and roll the dice (as detailed below) (each a “**Contestant**”, and collectively the “**Contestants**”). Contestant participation is non-transferable. No other individual may participate on behalf of a selected Qualifier or Contestant. THERE IS NO GUARANTEE THAT THE GRAND PRIZE WILL ACTUALLY BE AWARDED IN THIS CONTEST.
12. VERIFIED CONTESTANTS MUST REMAIN AT THE GRAND PRIZE EVENT UNTIL THE OFFICIAL CONCLUSION OF THE GRAND PRIZE EVENT. If a Verified Contestant departs the Grand Prize Event AT ANY TIME prior to the start or conclusion of the Grand Prize Event, REGARDLESS OF THE REASON, that Verified Contestant will be automatically disqualified from further participation in the Grand Prize Event.
13. **ONLY THE ACTUAL ENTRANT WHO ENTERED THIS CONTEST CAN PARTICIPATE. QUALIFIERS AND/OR VERIFIED CONTESTANTS CANNOT TRANSFER OR ASSIGN THEIR SPOTS TO OTHER PERSONS AT THE GRAND PRIZE EVENT. NO OTHER INDIVIDUAL MAY PARTICIPATE ON BEHALF OF AN ENTRANT, QUALIFER, OR VERIFIED CONTESTANT. NO PROXIES OR STAND-INS WILL BE ALLOWED.**
14. All Entrants and verified Contestants hereby agree to strictly follow all instructions and directions given by Station personnel at the Grand Prize Event and understand that any intentional failure to comply with these Contest rules or procedures or instructions given by Station staff will result in immediate disqualification.
15. In no event will any “deal-making” between Contestants be permitted. Station reserves the right to disqualify any person that it suspects has participated in or offered or accepted any type of “deal-making” with respect to this Contest.

16. Decisions of Station in the selection, notification and confirmation of any potential Contestant presenting themselves to the Station representative before the end of the check-in time or a verified Contestant's presence on site, and all matters related to this Contest are final and binding.
17. The Grand Prize Event dice roll will start at approximately 5:30pm (ET), or other time as solely determined and designated by Station and Sponsor. The following rules govern all dice roll attempts to win the Grand Prize:
 - a. Contestants must line up sequentially based on their number assigned at the time of check-in starting with the Contestant. This is the order in which each Contestant will participate starting with Contestant number one (1) being the first to participate in a dice roll attempt.
 - b. Contestants must, immediately prior to their dice roll attempt, print and sign their full name on the first unoccupied line of the provided official Contestant registration form, confirming their acknowledgement of these Contest rules. Each verified Contestant who properly signs the official sign in sheet and Contest rules acknowledgement will have one (1) opportunity to attempt to roll six (6) dice, provided by Station/Contest Administrator, and have each die come to rest with the predetermined winning side facing up, on a single dice roll attempt to spell out H-A-R-R-Y WNEW LOGO (symbol) (the "**Winning Dice Roll**"), subject to the requirements described below. The dice need not be in the specific order to read "H-A-R-R-Y WNEW LOGO", but must all be face up to display the correct letters and symbol.
 - c. Each winning letter and the symbol will appear on a maximum of one (1) side of one die within the entire set of dice.
 - d. A maximum of one (1) attempt will be permitted per Contestant, each subject to one re-roll opportunity as may be permitted in the event of an initial ineligible roll, as detailed below.
 - e. All dice roll attempts must occur in the presence of the appointed "**Contest Administrator**" and may NOT COMMENCE UNTIL THE CONTEST ADMINISTRATOR GIVES EACH CONTESTANT AN OKAY TO ROLL THE DICE, and each attempt must be fully recorded on video in its entirety. Any dice roll attempt not in the presence of the Contest Administrator and designated non-participating witness, that occurs prior to the Contest Administrator giving the OKAY to roll or that is not video recorded for any reason will be disqualified and is not eligible for the Grand Prize and such Contestant will NOT be given another opportunity to re-roll.
 - f. Contestants will not be permitted to take any practice or warm-up tosses prior to their attempt. Once a die has been rolled, their attempt is considered to be started.
 - g. Each eligible Contestant must roll all six (6) dice all at one time. Contestants may not attempt to change the outcome of any rolled die, by hitting the die with a subsequent roll attempt;
 - h. No dice, dice roll cup or roll area may be used other than that provided by the Contest Administrator.
 - i. Nothing may be done to the dice or rolling surface to enhance a Contestant's chance of winning. There is no setting or sliding of the dice allowed. Any attempt to set or slide the dice, as solely determined by the Contest Administrator, shall disqualify the Contestant, and no further attempts shall be allowed by that Contestant.
 - j. All six (6) dice must be rolled on each individual contest attempt. The winning outcome must occur during a single roll attempt – i.e. Contestants may not combine sides during multiple roll attempts. Each roll is its own unique Contest attempt and the six (6) winning sides must all land face-up on a single roll attempt.
 - k. Each die must be rolled a minimum of 2-feet in distance from the Contestant, in order to prevent the Contestant from altering, affecting, influencing, or enhancing the random outcome of any roll. The Station/Contest Administrator will designate the demarcation line that each die must cross during the roll.
 - l. All dice must come to rest lying flat.

- m. All dice must land on and remain on the designated dice rolling surface.
- n. No rolled die may come in contact with any person or object other than the designated rolling surfaces or walls. If any die comes in contact with another person or object (other than the dice roll surface or designated walls or backstop) for any reason; or if any person or object in any way interferes, alters, changes, influences or affects the random outcome of the roll, then the entire attempt is disqualified and the Contestant may not receive another attempt.
- o. Each die must be tossed in a completely random manner that does not allow the Contestant to “set” or “slide” the dice, alter or influence the random outcome of the roll.
- p. Contestants may roll the dice out of their hands, or using a Station/Contest Administrator provided dice roll cup (if any).
- q. Contestants are not allowed any practice or warm-up attempts. Once a die has been rolled, the Contestant’s attempt is considered to be started.
- r. If any of the following results occur during an individual attempt, that entire dice roll attempt is disqualified and the corresponding Contestant will be granted a maximum of one (1) additional re-roll attempt (the Contestant must re-roll all six (6) dice):
 - i. If the Administrator deems that any die has failed to cross the dice roll demarcation line;
 - ii. If any die is leaning in any manner;
 - iii. If any die leaves the designated dice roll playing surface;
 - iv. If any Contestant inadvertently drops a die as they are preparing to roll, and the dropped die does not meet the eligible dice roll requirements as stated in the Contest rules;
 - v. If any die fails to come to rest at least two (2) feet away from Contestant;
 - vi. In the event of an ineligible result on a re-roll attempt, the re-roll attempt is void and that Contestant is disqualified and the Contestant will not be eligible for any prize claim regardless of the outcome of their roll;
 - vii. Contestants may not receive more than one (1) re-roll attempt under any circumstances;

18. EACH ELIGIBLE CONTESTANT PRESENT SHALL BE PROVIDED ONE (1) OPPORTUNITY TO PARTICIPATE. IN THE EVENT OF MULTIPLE WINNING DICE ROLL ATTEMPTS, THE CASH VALUE OF THE GRAND PRIZE SHALL BE DISTRIBUTED AMONG ALL ELIGIBLE WINNING CONTESTANTS PER BELOW. IN THE EVENT THERE IS NO GRAND PRIZE WINNING DICE ROLL ATTEMPT BY AN ELIGIBLE CONTESTANT, THEN THE GRAND PRIZE WILL NOT BE AWARDED.

19. If any part or portion of the official dice or related Contest component is broken, damaged, manipulated, stolen or otherwise tampered with in any way, Station/Contest Administrator reserves the right to immediately end this Contest, without a Grand Prize Winner. Station and Sponsors are not responsible for any malfunction of the dice or related Contest component. In the event of any such malfunction, Station/Contest Administrator will determine in its sole discretion how to resolve the situation, which may include, without limitation, ending the Contest immediately without awarding any further prizes.

20. The odds of becoming an On-Air Qualifier depend upon the number and order of calls received. The odds of becoming an Online Qualifier depend upon the number of eligible online entries received. The odds of winning the Grand Prize by successfully rolling the six (6) dice to the Winning Dice Roll are 1:46,656.
