

“B93.7 In Labor Day Weekend” Photo Contest Contest Rules

These contest rules are specific to the above contest conducted by Audacy South Carolina, LLC d/b/a WFBC-FM (the “**Station**”). Except to the extent specifically set forth below with respect to this specific contest, the Station’s general contest rules apply to this contest as well. How to Enter

 - e. as a condition of entry, the Entrant must affirmatively check a box or an “I agree” button expressly confirming the following:
 - Entrant represents and warrants that he/she is over 21 years of age.
 - Entrant represents and warrants that the depicted child was born between 12:00 a.m. (ET) on September 4, 2026 and 11:59 p.m. (ET) on September 8, 2026 at any hospital located within Greenville, Anderson, Spartanburg, or Pickens Counties (each, an “**Upstate Hospital**”).
 - Entrant represents and warrants that he/she own the rights to, or have obtained permission to use, the photo submitted with the entry.
 - Entrant represents and warrants that there is only one (1) person visible in the attached video and that person is a child who the Entrant is the parent or legal guardian of.
 - Entrant represents and warrants that he/she authorizes Station to post the photo on Station’s website or social network sites or use the photo in any other way Station sees fit.

Photograph entries must not contain or depict any registered trade/servicemark or other copyrighted material other than those owned or licensed by the Entrants or the Station or a Contest Sponsor.
