

WOCL Sunny Side of Life Contest Rules

These contest rules are specific to the above contest conducted by WOCL(FM) (the “**Station**”). Except to the extent specifically set forth below with respect to this specific contest, the Station’s general contest rules apply to this contest as well. A copy of these specific contest rules is available on the Station’s website at www.1059sunnyfm.com/rules. To the extent that the Station’s general contest rules differ from these rules, these rules will govern and control with respect to this contest.

How to Enter

1. No purchase or payment of any kind is necessary to enter or win the “WOCL Sunny Side of Life” contest (the “**Contest**”). A purchase or payment will not increase your chance of winning.
2. For purposes of this Contest, an “**Eligible Home**” is defined as: (i) a single or multi-family stand-alone home (*i.e. co-ops, condos, trailers, and apartments are not eligible homes*); that is (ii) located within one (1) of the following Florida counties: Orange, Seminole, Osceola, Polk, Lake, Volusia, Flagler, or Brevard County.
3. An “**Entrant**” or his/her legal spouse, must be 21 years of age or older, a legal resident of one (1) of the following Florida counties: Orange, Seminole, Osceola, Polk, Lake, Volusia, Flagler, or Brevard County, and the record owner of an Eligible Home in order to be eligible to win the Prize (as described in Section 7 below) in this Contest.

The online entry form may require the Entrant to provide certain required contact information. **Limit one (1) entry per person and per email address.**
 - a. Entrants may be provided with an opportunity to opt-in for membership/participation as part of the entry process or, in the alternative, may be required to become a member/participate in clubs of (for example, email clubs, text clubs, and rewards programs) or to receive solicitations from Stations and/or its Sponsors.

The Station will attempt to contact the one (1) Winner by telephone based on the number provided in the submitted entry.
6. Odds of winning the Prize (as described in Section 7 below) in this Contest shall depend upon the number of entries received in the Contest.

Prizes

7. The one (1) verified Winner will receive the following: (i) one (1) gift certificate that is redeemable for one (1) initial twelve (12)-month Pro-Tech Home Comfort Club membership, subject to Pro-Tech’s separate member agreement, for one (1) Eligible Home within their service area, with an approximate retail value of \$294.00; and (ii) one (1) \$250.00 Visa Digital Gift Card (redeemable anywhere Visa Gift Cards are accepted, cannot be replaced if lost, stolen, or damaged, cannot be redeemed for cash) (the “**Prize**”).
