

WKBU – Rock You Like a Hurricane Garage Door Contest Rules

These contest rules are specific to the above contest conducted by WKBU-FM (collectively, the “**Station**”). Except to the extent specifically set forth below with respect to this specific contest, the Station’s general contest rules apply to this contest as well. A copy of these specific contest rules is available on the Station’s website at www.bayou957.com/rules. To the extent that the Station’s general contest rules differ from these rules, these rules will govern and control with respect to this contest.

How to Enter

1. No purchase or payment of any kind is necessary to enter or win the “Rock You Like a Hurricane Garage Door” contest (the “**Contest**”). A purchase or payment will not increase your chance of winning.
2. For purposes of this Contest, an “**Eligible Home**” is defined as: (i) a single or multi-family stand-alone home (*i.e. co-ops, condos, trailers, and apartments are not eligible homes*); that is (ii) located within one (1) of the following parishes in Louisiana or counties in Mississippi: Washington Parish, LA., Lafourche Parish, LA., Tangipahoa Parish, LA., Terrebonne Parish, LA., St. James Parish, LA., Plaquemines Parish, LA., St. John the Baptist Parish LA., St Charles Parish LA., St Bernard Parish LA., St. Tammany Parish LA., Jefferson Parish LA., Orleans Parish LA., Hancock County, MS. and Pearl River County, MS; AND (iii) is subject to final eligibility inspection and verification by Ace Garage Door, upon these criteria and the additional terms, conditions, and restrictions set forth in Sections 7 – 15 of these Contest rules.
3. An “**Entrant**” or his/her legal spouse, must be at least 21 years of age or older, a legal resident of the states of Louisiana or Mississippi, and the record owner of an Eligible Home in order to be eligible to win the Prize (as described in 7 below) in this Contest.
4. To enter beginning at approximately 12:00am (CT) on Monday, August 17, 2026 and ending at approximately 11:59pm (CT) on Sunday, September 6, 2026 (the “**Entry Period**”), go to www.bayou957.com/contests, click the “Rock You Like a Hurricane Garage Door” link, and complete and submit the online entry form, and click on the “I agree” box to confirm your agreement to the rules of the Contest during the Entry Period. The online entry form may require the Entrant to provide certain required contact information. Limit of one (1) entry per person and per email address.
 - a. Entrants may be provided with an opportunity to opt-in for membership/participation as part of the entry process or, in the alternative, may be required to become a member/participate in clubs of (for example, email clubs, text clubs, and rewards programs) or to receive solicitations from Stations and/or its Sponsors.

How to Win

5. At approximately 9:00am (CT) on Tuesday, September 8, 2026 one (1) Entrant will be selected in a random drawing of all eligible online entries received, and upon verification of eligibility and compliance with these rules, will win the Prize (as described in Section 7 below) in this Contest (the “**Winner**”). The Station will attempt to contact the one (1) Winner by telephone based on the number provided in the submitted entry and/or via the email address listed with the Software Provider at entry.
6. Odds of winning the Prize (as described in Section 7 below) in this Contest shall depend upon the number of entries received in the Contest.

Prizes

7. The one (1) verified Winner will receive the following: (i) one (1) standard only non-insulated garage door from Clopay or CHI, up to sixteen (16) feet wide and seven (7) feet tall, including installation,

valued at approximately \$2,500.00 and provided by Ace Garage Door (the “**Prize**”). The exact Prize unit to be determined based on the size, the installation, and the available options. Winner will receive the Prize that fits the Entrant’s Eligible Home on the date of entry. Installation includes removal and disposal of the existing garage door; installation of a new weather seal, tracks, and hardware; and reconnection of any existing garage door opener, subject to compliance with applicable safety codes and Ace Garage Door’s determination that the opener is suitable for reinstallation. There must be a garage door currently in place. The garage opening must be plumb. The Winner must provide a prepared opening for the garage door to be installed in (if one is not available, Ace Garage Door will provide a quote to prepare it for installation which will be the sole responsibility of the Winner in accordance with Section 7(g) below). There may not be an opening boarded up or covered by a tarp. To allow for the removal and installation of the garage door, a minimum clearance of twelve (12) feet in front of and twelve (12) feet behind the garage door opening must be clear of all obstructions, materials, and personal items. Winner must provide a clean and safe working environment for Ace Garage Door to install the garage door. Failure to provide any of the foregoing may result in disqualification of the Entrant. No portion of this Prize is transferable. Prize is not redeemable for cash. Winner is not entitled to any difference (in cash , credit, or other prizes) in value between \$2,500.00 and the actual value of the Prize unit determined appropriate for installation at the Eligible Home. Fulfillment of this Prize is subject to final eligibility inspection and verification of the potential winner’s home by Ace Garage Door to confirm such home meets the Eligible Home criteria set forth in these Contest rules. Potential winner has until up to five (5) days from the date of Station notification to allow the inspection and verification of home by Ace Garage Door. Install date must be mutually agreed upon by Winner and Ace Garage Door. Prize must be scheduled with Ace Garage Door for installation within ninety (90) days of Winner verification (the “**Prize Redemption Period**”) or Winner will be deemed to have forfeited the Prize. Winner understands and agrees that Station is not responsible for any delays or any damage resulting from the work at the home. The record owner of the property where the Prize will be installed must have a standard homeowner’s insurance policy on the home before any work will commence. Station may require proof of such policy.

8. The potential Winner is solely responsible for researching and obtaining any approvals from a neighborhood board or homeowner’s association (including, without limitation all costs and expenses associated with obtaining such approvals and authorizations). A potential Winner’s home may be deemed ineligible if installation is not allowed by a neighborhood board or homeowner’s association.
9. The Prize is for the installation of a new garage door. The cost of any additional construction that may be needed to remove an older garage door or any pre-existing structure in order to fulfill the Prize is not included. Winner will be responsible for any additional costs required for removal of any older garage door or any pre-existing construction.
10. If Winner wishes to extend or make garage door larger or any other change from the specific Prize and limitations described above, Ace Garage Door may provide a quote for additional work and, if agreed to by Winner in writing, will be the sole responsibility of the Winner.
11. **This Prize (in its entirety) will be forfeited if: (i) the Winner or his/her legal spouse on the date of winning either is not the record owner of an Eligible Home; and/or (ii) if the Winner’s home does not meet the Eligible Home definition and criteria as set forth in these rules. Stations reserve the right to require that the selected Winner provide one or more documents to evidence eligibility and qualification (including, without limitation, deeds or other proof of ownership). The record owner of the property where the Prize will be installed must have a standard homeowner’s insurance policy on the home before any work will commence. Station may require proof of such policy. Failure to provide any requested documents by the deadline requested by the Station will result in automatic disqualification, in which case, an alternate winner will be selected by Station in this Contest from among all other entries received.**

12. Winner understands and agrees that Station is not responsible for any delays or any damage resulting from the work at the home.
13. Like all work in a home, there is always the possibility of significant delays (due to delays in obtaining materials, supplies, third-party contractors, etc.) before, during, or after the construction of work and/or increased costs or time due to unforeseen circumstances or conditions. Winner understands and accepts any such risk of delay or increased costs in excess of the Prize value cap above. Winner understands and agrees that Station, Ace Garage Door, and its vendors are not responsible for any delays.
14. **WINNER UNDERSTANDS AND AGREES THAT HE/SHE IS RESPONSIBLE FOR ANY LIABILITY ARISING FROM WORK BEING CONDUCTED IN THEIR HOME AND AGREES TO COMPLETELY RELEASE STATION FROM ANY LIABILITY OR RESPONSIBILITY WHATSOEVER RESULTING FROM THE DAMAGE OF ANY PROPERTY OR INJURY OF ANY PERSON IN CONNECTION WITH OR ARISING FROM THE USE OF THE PRIZE AND THE WORK TO BE PERFORMED IN CONNECTION WITH THE PRIZE, REGARDLESS OF THE CAUSE. THE FOREGOING SHALL NOT RELIEVE THE CONTRACTORS PERFORMING ANY WORK AT THE HOME FROM ANY LEGAL RESPONSIBILITY OR OBLIGATION TO THE WINNER OR OTHERS.**
15. **STATION AND ACE GARAGE DOOR ARE NOT RESPONSIBLE IN ANY MANNER FOR ANY WARRANTIES, REPRESENTATIONS, OR GUARANTEES, EXPRESS OR IMPLIED, IN FACT OR LAW, RELATING TO PRODUCTS OR SERVICES PROVIDED AS THE PRIZE IN THIS CONTEST, INCLUDING WITHOUT LIMITATION, WITH THE EXCEPTION OF ANY STANDARD MANUFACTURER'S WARRANTY THAT MAY APPLY TO ANY OF THE PRODUCTS OR SERVICES RECEIVED.**

Sponsor(s)

16. The sponsors of this Contest are Audacy Louisiana, LLC d/b/a WKBU-FM and Ace Garage Door.

Other Rules Specific to This Contest

17. The entry process may require Entrants to login to, or to create, a free account with the third party provider of a software platform used by the Stations for such Contest(s) ("**Software Provider**"), by going to the Website, clicking on the Contest entry link, and completing and submitting the online registration form with all required information.
 - a. Limit one (1) account with the Software Provider per email address.
 - b. Software Provider is not a sponsor of this Contest, but Entrants may be required, as part of the entry process, to agree and consent to the Software Provider's terms of service and/or privacy policy, both of which will be available via a link during the entry or account registration process (collectively, the "**Software Provider Policies**").
 - c. If the Entrant elects to have their entry form pre-loaded or pre-populated with information from the Entrant's Facebook, Twitter, Google, or LinkedIn profiles, such Entrant authorizes the Software Provider and the Stations to access, utilize and/or pre-load to such entry form, applicable portions of Entrant's profile information from such account.
 - d. While agreement to the Software Provider Policies may be required in order to enter the Contest, the Software Provider Policies are not a part of these Contest Rules but are a separate agreement between the Entrant and Software Provider. In the event of any conflict between the Software Provider Policies and the Rules, the Rules will govern.
 - e. Stations are not responsible for any error or technical malfunctions associated with the Software Provider site that may affect any Entrant's ability to enter, to win, or to be properly considered in the Contest, regardless of the cause. In the event of a malfunction associated with the Software Provider site that the Stations in their sole and absolute discretion deems to

materially and adversely affect the Contest, the Stations reserve the right to (1) suspend the Contest; (2) terminate the Contest without a Winner; (3) terminate the Contest and select a Winner early; (4) provide alternative means of entry; and/or make any other changes to the Contest that the Stations deem appropriate under the circumstances. Any such changes, terminations or suspensions will be published on the Contest Rules Page, and in the Stations' sole and absolute discretion, may also be announced on-air, published elsewhere on the Website, and/or published on social media.

- f. Employees of Software Provider and its affiliates, their respective parents, affiliates, subsidiaries, advertising sponsors and promotional agencies, and the immediate family members of each are not eligible to win in this Contest.
