

Needham Bank Money Bag Contest

These contest rules are specific to the above contest conducted by Audacy Massachusetts, LLC d/b/a WEEI-FM (the “Station”). Except to the extent specifically set forth below with respect to this specific contest, the Station’s general contest rules apply to this contest as well. A copy of these specific rules and the Station’s general contest rules are available at the Station’s studio at 10 Guest St., Brighton, MA 02135, during regular business hours and on the Station’s website at www.audacy.com/weei/contest-rules. **To the extent that the Station’s general contest rules differ from these rules, these rules will govern and control with respect to this contest.**

How to Enter & Semi-Finalist Selection

1. No purchase necessary to enter or win the “Needham Bank Money Bag Contest” (the “Contest”). **TO BE ELIGIBLE TO WIN THE GRAND PRIZE IN THIS CONTEST, YOU MUST BE AVAILABLE TO PARTICIPATE IN AND BE PRESENT AT THE GRAND PRIZE EVENT ON THURSDAY, AUGUST 27, 2026 AT NEEDHAM BANK, LOCATED AT 14 ARTISAN DRIVE, SALEM, NH 03079 FROM 6:00am (ET) to 10:00am (ET)** (as further described in Sections 7 – 18 below, the “Grand Prize Event”).
2. This Contest is open to individuals who are both eighteen (18) years of age or older and a legal resident of MA, CT, NH, VT, or ME at the time of entry.
3. To enter this Contest starting at approximately 12:00am (ET) on Thursday, August 13, 2026 and ending at approximately 11:59pm (ET) on Sunday, August 23, 2026, go to www.weei.com/contests, click the “Needham Bank Money Bag Contest” entry graphic/link, complete the online registration form with all required information including entrant’s name, complete address (including city, state and zip), valid email address, age, and phone number(s) (including area code(s)), and then click submit. All on-line entries must be fully complete for all required information, and must be received by 11:59pm (ET) on August 23, 2026 to be eligible. Maximum of one (1) entry per person per day and per valid email address.
4. On or about Monday, August 24, 2026 at approximately 10:00am (ET), up to ten (10) entries will be randomly selected from among all eligible entries received and upon verification of eligibility and compliance with these Contest rules, each will become a “Semi-Finalist” and will get the opportunity to continue to participate in this Contest.

The potential Semi-Finalist will be notified within two (2) hours of being selected via telephone at the number such entrant provided when completing their online entry to this Contest. Station is only required to place one (1) phone call. Notification is deemed to have occurred immediately at the time the Station communicates such notification. Station reserves the right, but not the obligation, to attempt to contact the potential Semi-Finalist more than once via telephone, in its sole and absolute discretion, and will not be required to attempt to contact any potential Semi-Finalist an equal number of times or in the same manner. If the potential Semi-Finalist cannot be contacted, or if Station does not receive a response from the potential Semi-Finalist within twenty-four (24) of notification of selection by Station, then the potential Semi-Finalist will be disqualified. At the time of verification, the potential Semi-Finalist will be required to provide all information requested including their full name, complete address (including zip code), day and evening phone numbers, email and date of birth, and they must confirm their availability to attend the Grand Prize Event on Thursday, August 27, 2026 in order to be eligible to win. Any entrant who does not meet the eligibility requirements or who is unable or unwilling to attend the Grand Prize Event on Thursday, August 27, 2026 will be disqualified, will not become a Semi-Finalist, will not be entitled to participate in the Grand Prize Event and receive any prize in this Contest. If the potential Semi-Finalist does not complete and submit all documents required by the Station before the designated deadline communicated to the potential Semi-Finalist at the time of verification, then the potential Semi-Finalist will be disqualified. In the event any potential Semi-Finalist is disqualified, the Station has the right, but not the obligation, in its sole discretion, to select an alternate potential Semi-Finalist in a random drawing of all remaining eligible online entries received, time permitting.

- a. Maximum of one Semi-Finalist qualification per household.
 - b. Only Semi-Finalists selected and notified by Station will be eligible for a chance to participate in the Grand Prize Event. All other entrants are ineligible.
 - c. Decisions of Station in the selection of Semi-Finalists, and all matters related to this contest are final.
5. A PERSON MAY ONLY QUALIFY AS A SEMI-FINALIST ONCE IN THIS CONTEST AND MAY ONLY OBTAIN ONE (1) SEMI-FINALIST SPOT IN THE GRAND PRIZE EVENT.

6. Semi-Finalist(s) must be present at the date, time and location as specified by Station to participate in the Grand Prize Event. Any Semi-Finalist who fails to appear by the required deadline as stated by Station will be disqualified, and will not receive any alternate contest attempts, prize substitution or compensation. Sponsor reserves the right in its sole discretion to change the date, time or location of the Grand Prize Event. Semi-Finalists will be notified of any changes at the time of their selection and/or notification. Difficulties with getting to location to enter or participate in the contest are not the responsibility of Station.
7. By entering this Contest, all entrants acknowledge that by their participation in this Contest they hereby grant and provide their consent to being videotaped before, during and after the Grand Prize Event (including, without limitation, signing required forms) in association with this Contest

How To Win At The Grand Prize Event

8. **TO FURTHER PARTICIPATE IN THIS CONTEST AND TO BE ELIGIBLE FOR ANY ADDITIONAL PRIZE IN THIS CONTEST, SEMI-FINALISTS MUST ATTEND AND REMAIN PRESENT AT THE GRAND PRIZE EVENT ON THURSDAY, AUGUST 27, 2026 AT NEEDHAM BANK, LOCATED AT 14 ARTISAN DRIVE, SALEM, NH 03079, AND MUST AND CHECK-IN WITH STATION REPRESENTATIVES BETWEEN 6:30AM (ET) and 6:45AM (ET).** At check-in, Semi-Finalists must show a valid government issued photo identification, and sign "as is" one or more liability release agreement which, among other things, relieves and releases the Station and their affiliated companies and others from any and all liability with respect to the Contest and prizes. Failure to sign the required liability release agreements "as is" will result in automatic disqualification and ineligibility to participate further in this contest. **Any Semi-Finalist who has not checked-in by 6:45am (ET), or who is not waiting in line to do so by such deadline, will be disqualified, and such Semi-Finalist's opportunity to participate in any further in the Grand Prize Event shall be forfeited.** Each properly checked-in Semi-Finalist will be allowed to continue to participate in this Contest and upon completing check-in will receive one (1) **"Event Day Prize"** (as defined in Section 20 below). After check-in, each properly checked-in and verified Semi-Finalist will have their name printed on an individual slip of paper and each slip will be deposited by a Station representative into an official drawing box.
9. At approximately 8:00am (ET), the Station will conduct a finalist drawing to determine a grand prize finalist by which a Station representative will randomly select one (1) slip of paper from the official drawing box. The checked-in and verified Semi-Finalist who's name is written on such slip of paper will, subject to verification and compliance with these Contest rules, be the one (1) **"Finalist"** who will have the opportunity to participate in the **"Grand Prize Money Pick"** (as detailed below) for a chance to win the Grand Prize. Only one (1) verified Finalist will be allowed to participate in the Grand Prize Money Pick. Any Semi-Finalist not selected as the one (1) verified Finalist is not entitled to participate any further in this Contest and is not entitled to any grand prize.
10. In the event the selected potential Finalist is disqualified for any reason, the Station reserves the right, in its sole discretion to randomly select another slip of paper from the remaining Semi-Finalists in the drawing box as an alternate Finalist.
11. **VERIFIED SEMI-FINALISTS MUST REMAIN AT THE GRAND PRIZE EVENT UNTIL THE OFFICIAL CONCLUSION OF THE GRAND PRIZE EVENT.** If a verified Semi-Finalist or the Finalist departs the Grand Prize Event AT ANY TIME prior to the start or conclusion of the finalist drawing or Grand Prize Money Pick, **REGARDLESS OF THE REASON**, that Semi-Finalist or the Finalist will be automatically disqualified from further participation in the Grand Prize Event.

In order for the Grand Prize to be awarded to the one (1) selected Finalist, the Finalist must select two (2) money bags from the display of money bags provided by Station (there will be a total of fifteen (15) money bags to choose from). **The Finalist will only be entitled to the Grand Prize (as described in Section 21 below, the "Grand Prize") if all of the following are satisfied** (subject to verification and compliance with all of the following, the **"Grand Prize Winner"**):
 - a. The Finalist's selection of a money bag must occur in the presence of the designated WEEI contest representative and its designated non-participating witness. Any attempt of the Finalist not made in the presence of the witnesses for any reason will be disqualified and Finalist will not be eligible to try again nor to win the Grand Prize.

- b. Each of the fifteen (15) money bags will contain one (1) sealed contest envelope which is identical in size, shape, and color.
 - c. Each of the sealed Contest envelopes will be labeled with a number to encompass the entire range of numbers from one (1) to fifteen (15). No two (2) contest envelopes will be printed with the same number within the set of fifteen (15) contest envelopes. And there will only be one (1) contest envelope in each of the fifteen (15) money bags.
 - d. The Finalist will be required to select a maximum of two (2) money bags and remove the sealed contest envelope contained inside of each money bag. In the event any money bag contains more than one (1) sealed contest envelope, the Finalist will then be required to select only one (1) of the sealed envelopes.
 - e. The Finalist will then open and remove the certificates contained inside each of the contest envelopes.
 - f. The Finalist will reveal the enclosed certificates to the designated Station representative to determine if the certificates are a "Winning" or "Non-Winning" prize certificate.

 - i. And MUST satisfy the prize claim requirements described in Section 21 below.
13. ONLY THE ACTUAL ENTRANT WHO ENTERED THIS CONTEST CAN PARTICIPATE. SEMI-FINALISTS AND THE FINALIST CANNOT TRANSFER OR ASSIGN THEIR SPOTS TO OTHER PERSONS AT THE GRAND PRIZE EVENT. NO OTHER INDIVIDUAL MAY PARTICIPATE ON BEHALF OF AN ENTRANT, SEMI-FINALIST, OR FINALIST. NO PROXIES OR STAND-INS WILL BE ALLOWED.
14. THERE IS NO GUARANTEE THAT THE \$10,000 CASH GRAND PRIZE WILL ACTUALLY BE AWARDED IN THIS CONTEST
15. IMPORTANT: In the event of an error in the preparation of the contest materials or any tampering that results in the set of fifteen (15) sealed contest envelopes containing more than (2) "Winning Prize Certificates" other than the designated winning envelopes as designated by Million Dollar Media, that particular Finalist attempt is void. In that event, the Finalist will only be entitled to re-attempt the Contest, and will be provided a new set of sealed contest envelopes for his or her re-attempt on another date to be mutually agreed upon by the Finalist and the Station.
16. Station is not responsible for any agreements made by Semi-Finalists, verbal or written, to each other or to third parties due to their participation in this Contest, Contest and/or associated event or appearance with any person or entity. All Semi-Finalists and the Finalist must strictly follow all instructions and directions given by Station personnel at the Grand Prize Event. Failure to do so may result in immediate disqualification, as determined in the sole discretion of Station personnel.
17. In no event will any "deal-making" between participants in the Contest be permitted. Station reserves the right to disqualify any person that it suspects has participated in or offered or accepted any type of "deal-making" with respect to this Contest.
18. ALL ENTRANTS, SEMI-FINALISTS, AND THE FINALIST HEREBY AGREE TO STRICTLY FOLLOW ALL INSTRUCTIONS AND DIRECTIONS GIVEN BY THE STATION STAFF AT THE GRAND PRIZE EVENT AND UNDERSTAND THAT ANY INTENTIONAL FAILURE TO COMPLY WITH THESE CONTEST RULES OR PROCEDURES OR INSTRUCTIONS GIVEN BY STATION STAFF WILL RESULT IN IMMEDIATE DISQUALIFICATION. ALL DECISIONS MADE BY STATION STAFF AND/OR MANAGEMENT ARE FINAL.
19. Odds of becoming a Semi-Finalist depends on a number of circumstances, including, but not limited to, the number of entries received. The odds of a Semi-Finalist becoming the one (1) Finalist will be up to, but shall in no event exceed, 1:10. Odds of the Finalist winning the Grand Prize are 1:105.

Prize(s)

21. **EVENT DAY PRIZE:** The up to ten (10) verified Semi-Finalists who have properly checked-in at the Grand Prize Event by the check-in deadline will receive one (1) \$100 110 Grille gift card redeemable for purchased at any 110 Grille location.
22. **GRAND PRIZE:** Up to one (1) Grand Prize, if any, of \$10,000 Cash may be awarded in this Contest and will only be awarded upon satisfaction of the circumstances described in these Contest rules are satisfied and upon Grand Prize Winner validation and verification by Station and Million Dollar Media, subject to eligibility and compliance with these Contest rules. A maximum of one (1) Grand Prize will be awarded (if at all). The only person eligible to possibly win the Grand Prize will be the one (1) Grand Prize Winner. **In the event of a Grand Prize winner, winner will be required to sign one or more affidavits and/or liability release agreements "as is", provide a valid US federal or state government issued photo ID, and sign an IRS W-9 before the prize is awarded within three (3) business days of winning. Failure to do so for any reason within three (3) business days of winning at the Grand Prize Event will result in automatic forfeiture of the Grand Prize in this Contest and disqualification of such potential Grand Prize Winner.** If won, the \$10,000.00 Grand Prize will be payable to Grand Prize Winner only in the form of a company check available to be picked up by Grand Prize Winner within 6 to 8 weeks after the Grand Prize Winner has been determined. IN SUCH EVENT, THE PRIZE WILL NOT BE REAWARDED AND WILL REMAIN THE PROPERTY OF STATION.
23. No family member, friend or other person will be allowed to accept the prize on behalf of the Grand Prize Winner.
24. Notarized affidavits and recorded statements may be required from the contest administrator, witness and Grand Prize Winner to verify compliance with terms and conditions.

Other Rules Specific to This Contest

26. In addition to the eligibility restrictions set forth in the Station's general contest rules, employees (including, without limitation, part-time or temporary employees) of Million Dollar Media and its respective parent entities, subsidiaries, affiliated companies and advertising and promotion agencies at any time during the applicable contesting period and the immediate family (*i.e.*, current and ex-spouses, parents, grandparents, children, grandchildren, and siblings and in-laws and steps in any of the foregoing categories) and other household members (*i.e.*, roommates, housemates, significant others, and partners of each legally residing at the same address) are NOT eligible to enter and/or to win the Contest.
27. In the event that the Grand Prize Event needs to be rescheduled for any reason, such postponement will be announced on air and on the Station's website. of which will be available via a link during the entry or account registration process (collectively, the "Software Provider Policies").

In the event of a malfunction associated with the Software Provider site that the Station in its sole and absolute discretion deems to materially and adversely affect the Contest, the Station reserves the right to (1) suspend the Contest; (2) terminate the Contest without a Winner; (3) terminate the Contest and select a Winner early; (4) provide alternative means of entry; and/or make any other changes to the Contest that the Station deems appropriate under the circumstances. Any such changes, terminations or suspensions will be published on the Contest Rules Page, and in the Station's sole and absolute discretion, may also be announced on-air, published elsewhere on the Website, and/or published on social media.
- f. Employees of Software Provider and its affiliates, their respective parents, affiliates, subsidiaries, advertising sponsors and promotional agencies, and the immediate family members of each are not eligible to win in this Contest.
