

KSON's High-Low Jackpot Contest Rules

These contest rules are specific to the above contest conducted by Audacy San Diego, LLC d/b/a [KSON-FM] (collectively, the “**Station**”). Except to the extent specifically set forth below with respect to this specific contest, the Station’s general contest rules apply to this contest as well. A copy of these specific contest rules and the Station’s general contest rules are available at the Station’s studio at [9665 Granite Ridge Dr, Suite 600, San Diego, CA 92123] during regular business hours and on the Station’s website at KSON.com/rules. **To the extent that the general contest rules differ from these rules, these rules will govern and control with respect to this Contest.**

Entry/Winning

1. No purchase or payment of any kind is necessary to enter or win the KSON’s High-Low (the “**Contest**”). A purchase or payment will not increase your chance of winning.
2. Listeners can enter the Contest by listening to the Station weekdays (Monday – Friday) (excluding holidays) between August 24, 2026 and October 23, 2026 or until the last jackpot is correctly guessed, at approximately 7:30am PT, 8:00am PT, 12:00pm PT, 2:00pm PT, and 3:00pm PT each weekday for the Station on-air personality to play KSON’s High-Low sounder. After the sounder is played, the 10th caller at 833-287-1037 will be given an opportunity to guess the cash amount of the jackpot. (Calls to other numbers, including the Station’s general number will not be accepted.) The 10th caller will have ten seconds or less to guess the exact amount (dollars and cents) of the jackpot. The on-air personality then will indicate whether the guess is too high, too low or the correct amount in the cash jackpot. A prize will be awarded, upon confirmation of eligibility, to the 10th caller who guesses the correct amount (dollars and cents) in the jackpot within the allotted 10 seconds and the contestant will win the jackpot amount (each a “Winner”). Another game will begin and the Contest will continue until the sooner of: (i) the maximum amount has been awarded in this Contest; (ii) or until October 23, 2026. The maximum amount of all prizes awarded in this Contest is limited to \$1,000.00. **WARNING: Online listeners to streamed broadcasts may experience a lag in transmissions due to buffering limitations. Contest Participants should not rely on streamed broadcasts.**
3. The cash amount of each Jackpot will be pre-determined by Station prior to accepting any guesses.

Prize(s)

4. The odds of an entrant selecting the correct jackpot amount are 1 in 10 or better if prior contestants have already guessed on a particular jackpot.
5. Up to 10 prizes will be awarded in this Contest. Cash prizes will be paid by company check and will be available within 12 weeks of Winner’s completion of all required Station documents and verification of eligibility. The maximum amount of all prizes awarded in this Contest is limited to \$1,000.00.
