

KMXB “Mega Minute” Disneyland Fall 26’ Contest Rules

These contest rules are specific to the above contest conducted by Audacy Nevada, LLC d/b/a KMXB (collectively, the “**Station**”). Except to the extent specifically set forth below with respect to this specific contest, the Station’s general contest rules apply to this contest as well. A copy of these specific contest rules and the Station’s general contest rules are available at the Station’s studio at 7255 S Tenaya Way Suite 100, Las Vegas, NV 89113 during regular business hours and on the Station’s website at <https://www.audacy.com/kluc/contest-rules>. **To the extent that the general contest rules differ from these rules, these rules will govern and control with respect to this contest.**

Entry/Winning

1. NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THE “Minute to Win It” Contest (the “**Contest**”). A purchase or payment will not increase your chance of winning.
2. To enter from Monday, August 31, 2026 through Thursday, September 10, 2026 listen to the Station weekdays (Monday – Friday only, excluding holidays, Friday, September 4, 2026 and Monday, September 7, 2026) at approximately 7:30am (PT) each weekday and listen for the cue to call from the on-air personality (each, a “**Contest Play**”). After the cue to call is announced, the 20th caller to get through to the Station at 702-364-9400, subject to verification of eligibility and compliance with these Contest Rules, will have the opportunity to play for a Qualifying Prize (*as described in Section 7 below*) (each a “**Contestant**”). The Contestant will then be given a total of sixty seconds (:60) to answer ten (10) trivia questions read by the on-air personality. The sixty seconds (:60) will start immediately after the on-air personality has fully announced the 1st question and continue all the way through until the sixty (:60) seconds is up. The Contestant will have the option to say “Pass” if they want to move on to the next question and come back to it later only and if there is time left after all ten (10) questions have been asked by the on-air personality. The time will pause after the last question has been answered and remaining time will be announced by the on-air personality to answer questions that have gone unanswered by the Contestant. Only the first (1st) answer given will be accepted, a Contestant may not change their answer after one has already been given. A designated member of the Station will be an official judge and time keeper who knows the correct answers to all ten (10) of the trivia questions and will be the SOLE determiner of whether a guess is correct or not and whether all ten (10) questions have been answered correctly within the sixty seconds (:60). These decisions are not appealable.
 - a. If the Station judge determines that the Contestant correctly answers all ten (10) trivia questions before the end of the sixty seconds (:60), that Contestant will win the Qualifying Prize (*as described in Section 7 below*), (each a “**Qualifying Prize Winner**”) and be qualified to win the Grand Prize (*as described in Section 8 below*). Should a Contestant give an incorrect answer to a trivia question, the Contest Play will stop, the Contestant will not win the Qualifying Prize, another caller will not be taken for that Contest Play, and the remaining unanswered questions will not be read on-air.
 - b. If the Station judge determines that a trivia question was not correctly answered by a Contestant, that Contestant will not be entitled to any Qualifying Prize or Grand Prize in this Contest.
 - i. **The trivia questions will be predetermined by the Station prior to Contest start. All ten (10) trivia questions will be the same for each Contest Play.**

iii. CALLS TO OTHER NUMBERS, OTHER THAN THE ANNOUNCED NUMBERS, INCLUDING THE STATION'S GENERAL NUMBER, WILL NOT BE ACCEPTED.

3. In the event that a Contestant is not able to correctly answer all ten (10) trivia questions in sixty seconds (:60), a cue to call will then be announced. The 20th caller to get through to the Station at 702-364-9400, subject to verification of eligibility and compliance with these Contest Rules, will become a Qualifying Prize Winner.
4. On September 14, 2026 at approximately 9:00am (PT) one (1) Qualifying Prize Winner will be selected in a random drawing of all Qualifying Prize Winners, and subject to verification of eligibility and compliance with these Contest Rules, will become the **"Grand Prize Winner"**.
5. There will be up to, but in no event more than, seven (7) verified Qualifying Prize Winners in this Contest and up to, but in no event more than, one (1) Grand Prize Winner in this Contest.
6. Odds of becoming a Qualifying Prize Winner depend upon the number of calls received for any particular Contest Play and on the trivia knowledge of each Contestant. Odds of a Qualifying Prize Winner winning the Grand Prize are 1 in 7.

Prize(s)

7. Each of the up to seven (7) Qualifying Prize Winners in this Contest will each receive four (4) Disneyland Resort 2-Day, 1-Park per day tickets (tickets valid at Disneyland or Disney California Adventure but not both parks on the same day, tickets must be used by September 15, 2027) (each a **"Qualifying Prize"**), valued at approximately \$1,320.00 and is courtesy of Disney Destinations, LLC. Travel and hotel are NOT included in the Qualifying Prize.
8. The up to one (1) Grand Prize Winner in this Contest will receive one (1) Disneyland Resort vacation package consisting of the following: (i) hotel accommodations for the Grand Prize Winner and up to three (3) guests (one (1) standard room/quad occupancy, including room tax, subject to certain room availability) for up to two (2) consecutive nights at one of the Hotels of the Disneyland Resort, as selected by Disney in its sole discretion (standard daily hotel parking at the premises is not included unless Grand Prize Winner resides on the island of Oahu); (ii) two (2) nights parking for one vehicle; and (iii) four (4) 3-Day, 1-Park per day tickets to the Disneyland Resort (valid for admission to Disneyland and Disney California Adventure) (tickets must be used by September 15, 2027), (the **"Grand Prize"**). Grand Prize is valued at approximately \$3,312.00, and is courtesy of Disney Destinations, LLC. - e. An inherent risk of exposure to COVID-19 exists in any public place where people are present. The Qualifying Prize Winners and Grand Prize Winner and any guest(s), if

All winner fulfillment paperwork must be completed during business hours; Monday through Friday (excluding holidays) from 9:00am - 5:30pm (PT) and/or 24 hours prior to the event date in order for prize to be distributed.
