

KROQ SBD Airport 4th Anniversary Contest Rules

These contest rules are specific to the above contest conducted by Audacy California, LLC, operator of KROQ-FM (collectively, the “**Station**”). Except to the extent specifically set forth below with respect to this specific contest, the Station’s general contest rules apply to this contest as well. A copy of these specific contest rules and the Station’s general contest rules are available on the Station’s website at www.kroq.com/rules. To the extent that the Station’s general contest rules differ from these rules, these rules will govern and control with respect to this contest.

How to Enter

1. No purchase necessary to enter or to win the SBD Airport 4th Anniversary Contest (the “**Contest**”). A purchase or payment will not increase your chance of winning.
2. For purposes of this Contest:
 - a. The term “**Artist**” means any solo artist, duo, or group made up of persons who are all at least eighteen (18) years of age or older as of the entry date;
 - b. “**Entrant**” refers to each and every performer (collectively, jointly and severally) associated with the entry submitted in this Contest;
 - c. “**Song**” refers to each entry submitted by each Artist, as further explained in Section 5 below;
 - d. **Each and all performers on any Song submitted for entry in this Contest must each be an Entrant, and each Entrant, along with each and all other performers on the Song submitted for entry in this Contest, will be required to individually complete and sign the Official Participation and Release Form (Attachment A) in accordance with Section 4(b) below;**
 - e. Each Artist must designate one (1) person as the “**Leader**”. The Leader must be a performer with the Artist and be a legal resident of one of the following California counties as of the entry date: Los Angeles, Orange, Riverside, Ventura, or San Bernardino.
3. The entry/registration process will require you to complete the online entry/registration form by submitting the Entrant’s (or Leader’s if applicable) name, address, phone number, e-mail address, and a link to the Artist’s social media page. Limit one (1) account per e-mail address and limit one (1) entry per account. **ONCE AN INDIVIDUAL HAS ENTERED THIS CONTEST AS AN ARTIST, THEY MAY NOT ENTER THE CONTEST AGAIN AS A PERFORMER MEMBER OF A DIFFERENT ARTIST. MULTIPLE ENTRIES FROM THE SAME ENTRANTS WILL BE DISCARDED.** Only the first chronologically received entry will be considered. All subsequent entries will be discarded. The person completing the entry must be an Entrant but does not have to be the designated leader.
4. Eligible Artists may enter this Contest starting at 12:00am (PT) on Monday, September 7, 2026 and ending at 11:59pm (PT) on Sunday, September 27, 2026 (the “**Entry Period**”) by going to the Station website at www.kroq.com/contests and clicking the SBD Airport 4th Anniversary Contest link and complete ALL of the following steps:
 - a. Click the “Upload Song” (may also appear as “Submission”) tab and submit your entry, including your one (1) Song (as further defined in Section 5 below), your name or the Artist name, and affirmatively check the box or “I agree” button expressly confirming the following:
 - i. Entrant represents and warrants that he/she is over eighteen (18) years of age and that at least one (1) member of the Artist is a legal resident of one of the following California counties as of the entry date: Los Angeles, Orange, Riverside, Ventura, or San Bernardino.
 - ii. Entrant acknowledges and agrees that the Contest rules are available to him/her at www.kroq.com/rules, has had an opportunity to review them before entering this Contest and agrees to be legally bound by those Contest rules.

- b. Each Leader must complete and return a Participant Agreement and Release Form (*Attachment A below*), individually completed and signed by each and all of the performers on the Song submitted for entry in this Contest as instructed on the Participant Agreement and Release Form by not later than 10:00am (PT) on Tuesday, September 29, 2026 ("Agreements"). **FAILURE TO COMPLETE AND SUBMIT PARTICIPANT AGREEMENT AND RELEASE FORM TO STATION AS INSTRUCTED ABOVE WILL RESULT IN IMMEDIATE DISQUALIFICATION.** Entrant(s) and signatories agree that (a) any electronically submitted signatures are deemed to be and are acceptable as if they were original signatures, and (b) to keep the original of the fully signed entry form for at least six (6) months after this Contest ends and to provide it to Station, upon Station's request, at any time prior to six (6) months after this Contest ends whether or not the entrant is a winner in this Contest.
5. Song Requirements:
- a. Only one (1) Song may be submitted per Entrant for entry in this Contest (once an individual has entered this Contest as an Artist, they may not enter the Contest again as a performer or member of a different Artist).
 - b. Song must be uploaded (using the method described in Section 4 above) in one of the following file types: .mp3 or .wav of no more than 30MB.
 - c. Songs that exceed one (1) song will not be disqualified, but Station will only be obligated to listen to the first Song in determining whether the Entrant(s) will advance for consideration as a Finalist in this Contest. Station will make such a decision on a case by case basis based in its sole discretion and is not required to make the same determination for every Song submission entered (it may treat different entrants/Songs differently, in its sole discretion).
 - d. A Song that includes (or is suspected to include, in Station's sole discretion) any pre-recorded music performed by anyone other than the Entrant (in whole or in part) will result in disqualification from this Contest.
 - e. **WHETHER OR NOT SELECTED AS A WINNER OR FINALIST, ALL ENTRIES (INCLUDING THE SONGS SUBMITTED) BECOME THE SOLE PROPERTY OF STATION AND MAY BE USED BY STATION IN ANY MEDIUM IT DEEMS DESIRABLE NOW OR IN THE FUTURE WITHOUT ANY COMPENSATION TO THE ENTRANT(S), OR ANY OF THE PERSONS WHO APPEAR IN OR PROVIDE MATERIALS FOR THE SONG.** Station retains sole and exclusive possession and retains all rights to use any entry, or any part thereof, including but not limited to the musical performance submitted with an entry, indefinitely in any advertising, promotion or use of any other kind including, but not limited, to on-air and online usage without any compensation to Entrants or any third parties. The aforementioned stipulations apply to all winning and non-winning Entries.
 - f. Station is not responsible for any costs associated with submitting any Song or any costs arising out of participating in the Contest or failure to adhere to official Contest rules.
6. **FAILURE TO SUBMIT ANY REQUIRED ENTRY MATERIALS AND/OR COMPLY WITH ANY ENTRY REQUIREMENT AS SET FORTH IN THESE RULES WILL RESULT IN DISQUALIFICATION. STATION HAS NO OBLIGATION WHATSOEVER TO NOTIFY ANY ENTRANT(S) IF AN ENTRY HAS BEEN DISQUALIFIED AND WILL NOT DO SO.**
7. **By entering this Contest, Entrants understand and agree that Station may elect to use any entry submitted for entertainment purposes and may choose to comment on, mock, poke fun at, and/or mimic any entry submitted. Entrants waive any right to make any claim against Station or any Contest sponsors with respect to any comments-disparaging or otherwise-made regarding such Entrant's entry. Additionally, Contest judges may comment on/critique entries from time to time and Station may elect to feature such entries with the judges' commentaries online, on-air, or in any other medium it desires. Entrants understand and agree that such commentary/critiques from Contest judges may depict an entry in a**

positive or negative light (such feedback is not determinative of selecting a winner) and by submitting an entry into this Contest, Entrants waive any right to make any claim against Station or any Contest sponsors.

8. By entering this Contest, Entrants represent, warrant, and covenant they will be available and able to perform before The Elovaters and DENM at San Bernardino International Airport's 4th Annual Cruising At Altitude Party at San Bernardino International Airport, 105 North Leland Norton Way, San Bernardino, CA 92408 on Saturday, October 31, 2026 around 7:00pm (PT). Further, Entrants represent, warrant, and covenant that they have obtained permission from all performers, consenting to their performance at San Bernardino International Airport's 4th Annual Cruising At Altitude Party, 105 North Leland Norton Way, San Bernardino, CA 92408 on Saturday, October 31, 2026.
9. By entering this Contest, Entrants understand and agree that voting will be conducted as part of the Contest, but will not determine the winner. Voting will be for entertainment purposes only.

How to Win

10. On Monday, September 28, 2026 a panel of Station judges will review all complete eligible Songs and select the five (5) Songs they deem best based on any lawful criteria from among all entrants who submitted valid and eligible Songs. Those five (5) Entrants will become **"Finalists"** and they will have their Artist names and a link to the Artist's social media page posted on Station's website for listener voting starting at 12:00am (PT) on Wednesday, September 30, 2026 until 11:59pm (PT) on Sunday, October 11, 2026 (the **"Voting Period"**). **LISTENER VOTING IS FOR ENTERTAINMENT PURPOSES IN THIS CONTEST, AND MAY BE, IN STATION'S SOLE DISCRETION, ONE OF MANY FACTORS TAKEN INTO CONSIDERATION BY STATION JUDGES, HOWEVER, LISTENER VOTING WILL NOT BE DETERMINATIVE IN SELECTING THE WINNER.**
11. On or about Monday, October 12, 2026, a panel of Station judges will review all complete eligible Finalist Songs and select the one (1) Song they deem best based on any lawful criteria, which may include without limitation, a) originality, b) relevance, c) quality of performance, and/or d) the number of votes received during the Voting Period, as the winners of this Contest, subject to verification of eligibility and compliance with the Contest rules (**"Winner"**). Each and all of the individual Entrants whose names appear on the Contest Participation and Release form (Attachment A) associated with the one (1) Winner will become a Winner, jointly and severally, subject to verification of Contest eligibility and compliance with these rules. The Winner will be notified of winning via email to the email address provided on the winning entry following the Winner selection.

Prize(s)

13. Up to one (1) Prize (the **"Prize"**) in this Contest will be awarded to the one (1) verified Winner. The Prize includes the following: the opportunity for the Winning Artist to perform a twenty (20) to thirty (30) minute on-stage performance prior to the performance of The Elovaters and DENM at San Bernardino International Airport's 4th Annual Cruising at Altitude Party at San Bernardino International Airport, located at 105 North Leland Norton Way, San Bernardino, CA 92408, on Saturday, October 31, 2026 at approximately 7:00pm (PT). **Backline and production for the event will be provided by and determined by the event organizer and Station in their sole and absolute discretion. Any requests for backline and production by Artist, or any backline or production provided by Artist is per advance and subject to the mutual approval of event organizers and Station.** The Prize has no real or monetary value, and is courtesy of San Bernardino International Airport. Exact time of Winner arrival and performance is to be determined. **Prize does NOT include transportation of Winner to and from Venue for any rehearsal(s) or actual performance on night of the concert.** The Prize is contingent upon the concert occurring

on Saturday, October 31, 2026, which is beyond the Station's control. Station is not responsible if a Winner is unable to go on stage and perform if the artist (The Elovaters and DENM) or Venue determines this is not allowable for any reason. In the event of illness, act of god, scheduling conflict or any other reason, Station is not responsible for this portion of the prize and no alternate prize will be awarded.

- a. The Winner and any guest(s), if applicable, must comply with any and all COVID-19 vaccination, screening, testing, safety and related requirements imposed or required by (if applicable) the Station, the venue, event promoter, sponsors, travel providers, hotels, governmental authorities or others in connection with the receipt, use, and redemption of the Prize. Refusal to comply with all applicable COVID-19 requirements will result in forfeiture of the Prize and no replacement or alternate Prize will be provided. All cancellations are deemed beyond the control of the Station and its sponsors. This includes, but is not limited to, event cancellations due to any pandemic or epidemic constituting a public health emergency, including those subject to government mandated quarantines, travel restrictions, or stay-at-home orders. The Station and/or its sponsors shall in no way be responsible under any circumstances whatsoever for replacing, and/or for reimbursing any Winner(s) with any form of compensation for, any Prize(s) or portion(s) thereof forfeited due to the refusal of the Winner(s) and/or their guest(s) to comply with all applicable COVID-19 requirements and/the cancellation of any event, nor will any alternate Prize(s) be provided.

Sponsor(s)

14. The sponsors of this Contest are Audacy California, LLC, operator of KROQ-FM and San Bernardino International Airport.

Other Rules Specific to This Contest

15. Station is not responsible for technical problems that may impact the ability of a .mp3 or .wav Song to properly download and play on Station computer.
16. **Entry in this contest is gratis and not in exchange for any airplay, for the Entrant(s) or anyone else. Any decision by the Station to play any such music (whether in connection with the Contest or otherwise) will be at the sole discretion of the Station and is in no way implicitly or explicitly in exchange for participation in this contest. If Station elects to play any such entry submission that features original music during or after this contest, Station may identify the entrant as a sponsor. IN NO EVENT DOES PARTICIPATION IN THIS CONTEST MEAN THAT ANY ENTRANT IS ENTITLED TO ANY AIRPLAY OF ANY MUSIC INCLUDED IN THEIR ENTRY SUBMISSION.**
17. The entry process may require Entrants to login to, or to create, a free account with the third party provider of a software platform used by the Station for such Contest(s) ("**Software Provider**"), by going to the Website, clicking on the Contest entry link, and completing and submitting the online registration form with all required information.
 - a. Limit one (1) account with the Software Provider per email address.
 - b. Software Provider is not a sponsor of this Contest, but Entrants may be required, as part of the entry process, to agree and consent to the Software Provider's terms of service and/or privacy policy, both of which will be available via a link during the entry or account registration process (collectively, the "**Software Provider Policies**").
 - c. If the Entrant elects to have their entry form pre-loaded or pre-populated with information from the Entrant's Facebook, Twitter, Google, or LinkedIn profiles, such Entrant authorizes the Software Provider and the Station to access, utilize and/or pre-load to such entry form, applicable portions of Entrant's profile information from such account.
 - d. While agreement to the Software Provider Policies may be required in order to enter the Contest, the Software Provider Policies are not a part of these Contest Rules but are a separate agreement

between the Entrant and Software Provider. In the event of any conflict between the Software Provider Policies and the Rules, the Rules will govern.

- e. Station is not responsible for any error or technical malfunctions associated with the Software Provider site that may affect any Entrant's ability to enter, to win, or to be properly considered in the Contest, regardless of the cause. In the event of a malfunction associated with the Software Provider site that the Station in its sole and absolute discretion deems to materially and adversely affect the Contest, the Station reserves the right to (1) suspend the Contest; (2) terminate the Contest without a Winner; (3) terminate the Contest and select a Winner early; (4) provide alternative means of entry; and/or make any other changes to the Contest that the Station deems appropriate under the circumstances. Any such changes, terminations or suspensions will be published on the Contest Rules Page, and in the Station's sole and absolute discretion, may also be announced on-air, published elsewhere on the Website, and/or published on social media.
