

KLUC Disney Hi-Low Fall 26' Contest Rules

These contest rules are specific to the above contest conducted by Audacy Nevada, LLC d/b/a KLUC (collectively, the “**Station**”). Except to the extent specifically set forth below with respect to this specific contest, the Station’s general contest rules apply to this contest as well. A copy of these specific contest rules and the Station’s general contest rules are available at the Station’s studio at 7255 S Tenaya Way Suite 100, Las Vegas, NV 89113 during regular business hours and on the Station’s website at <https://www.audacy.com/kluc/contest-rules>. **To the extent that the general contest rules differ from these rules, these rules will govern and control with respect to this contest.**

Entry/Winning

1. No purchase or payment of any kind is necessary to enter or win the Disneyland Hi-Low (the “**Contest**”). A purchase or payment will not increase your chance of winning.
2. Listeners can enter the Contest by listening to the Station weekdays (Monday – Friday) (excluding holidays) between Tuesday, September 8, 2026 and Friday, September 18, 2026 between 6:00am (PT) and 3:00pm (PT) each weekday for the Station on-air personality to play KLUC’s “Disney Hi- Lo” sounder. After the sounder is played, the 25th caller at 702-364-9898 will be given an opportunity to guess the winning number for that sounder. Calls to other numbers, including the Station’s general number will not be accepted. The twenty-fifth (25th) caller will have the opportunity to guess the winning number between 001-050. The on-air personality then will indicate whether the guess is too high, too low or the correct number for the prize. If the 25th caller correctly guesses the winning number for that sounder, upon verification of eligibility, they will win one (1) Qualifying Prize (*as described in Section 6 below*) (each a “**Qualifying Prize Winner**”) and will be qualified to win the Grand Prize (*as described in Section 7 below*). There will be up to fifteen (15) Qualifying Prizes awarded in this Contest. In the event that a twenty-fifth (25th) caller is not able to correctly guess the winning number, that caller will be not become a Qualifying Prize Winner and the on-air personality may then move on to another selected caller, if necessary. This process may continue until the sooner of 3:00pm (PT) each weekday or until a Qualifying Prize Winner is selected for that day, whichever happens first.
 - a. **WARNING: Online listeners to streamed broadcasts may experience a lag in transmissions due to buffering limitations. Contest Participants should not rely on streamed broadcasts.**
3. Each winning number will be pre-determined by the Station prior to accepting any guesses.
4. On September 21, 2026 at approximately 9:00am (PT) one (1) Qualifying Prize Winner will be selected in a random drawing of all Qualifying Prize Winners, and subject to verification of eligibility and compliance with these Contest Rules, will win the Grand Prize (*as described in Section 7 below*) and become the “**Grand Prize Winner**”.
5. Odds of being the twenty-fifth (25th) caller after each sounder airs depend upon the number of calls received for any particular sounder. Odds of a Qualifying Prize Winner winning the Grand Prize are no greater than 1 in 15.

Prize(s)

6. Each of the up to fourteen (14) Qualifying Prize Winners in this Contest will each receive four (4) Disneyland Resort 2-Day, 1-Park per day tickets (tickets valid at Disneyland or Disney California Adventure but not both parks on the say day, tickets must be used by September 15, 2027) (each a “**Qualifying Prize**”), valued at approximately \$1,320.00 and



is courtesy of Disney Destinations, LLC. Travel and hotel are NOT included in the Qualifying Prize.

7. The up to one (1) Grand Prize Winner in this Contest will receive one (1) Disneyland Resort vacation package consisting of the following: (i) hotel accommodations for the Grand Prize Winner and up to three (3) guests (one (1) standard room/quad occupancy, including room tax, subject to certain room availability) for up to two (2) consecutive nights at one of the Hotels of the Disneyland Resort, as selected by Disney in its sole discretion (standard daily hotel parking at the premises is not included unless Grand Prize Winner resides on the island of Oahu); (ii) two (2) nights parking for one vehicle; and (iii) four (4) 3-Day, 1-Park per day tickets to the Disneyland Resort (valid for admission to Disneyland and Disney California Adventure) (tickets must be used by September 15, 2027), (the **"Grand Prize"**).
