

K-FROG's ROAD TO STAGECOACH CONTEST RULES

These contest rules are specific to the above contest conducted by Audacy California, LLC d/b/a KFRG-FM & KXFG-FM (collectively, the "**Station**"). Except to the extent specifically set forth below with respect to this specific contest, the Station's general contest rules apply to this contest as well. How to Enter

From 8:00 AM (PT) on September 14, 2026 through the earlier of either at 3:00 PM (PT) on December 9, 2026 or the point at which fifty (50) prizes have been awarded in this Contest, whichever is sooner, go to www.kfrog.com/contests, click on the link to enter this Contest, and complete the entry form with all applicable and required information.
