

KNRK(FM) My Viking Weekend 2026 Contest Rules

These contest rules are specific to the above contest conducted by Audacy Oregon, LLC, operator of KNRK(FM) (the “**Station**”). Except to the extent specifically set forth below with respect to this specific contest, the Station’s general contest rules apply to this contest as well. To the extent that the general contest rules differ from these rules, these rules will govern and control with respect to this Contest.

How to Enter and Win

1. No purchase or payment of any kind is necessary to enter or win the KNRK(FM) My Viking Weekend 2026 Contest (the “**Contest**”). A purchase or payment will not increase your chance of winning.
2. To be eligible to participate in this Contest, entrants must be twenty-one (21) years of age or older and a legal U.S. resident of OR or WA as of the date of entry in this Contest. **Entrant must also have a valid passport as of Monday, September 28, 2026 in order to win the Grand Prize (as described in Section 7 below) in this Contest.** The Grand Prize Winner’s guest must be twenty-one (21) years of age or older and **must have a valid passport as of Monday, September 28, 2026 to travel with the Grand Prize Winner.**
3. Listen to the Station every weekday starting on Monday, September 14, 2026 and ending Friday, September 25, 2026, (each, a “**Contest Day**”) at approximately 7:00am (PT) (each, a “**Contest Play**”) for the Station to announce a unique Contest codeword (each, a “**Codeword**”). You may enter by texting the Codeword to the Station text number 971-717-0947 before the end of the “**Entry Period**” at 10:00am (PT) for each Contest Play as follows:
 - a. There will be up to ten (10) Contest Plays in this Contest.
 - b. Text messages sent to any text number other than 971-717-0947, text messages sent to 971-717-0947 that include any Codeword other than the designated and announced Codeword for a particular Contest Play, and/or text messages sent to 971-717-0947 without any Codeword will not be accepted for Contest entry and disqualified without notice.
 - c. There is no limit on the number of times an entrant may text a Codeword during the Entry Period of a Contest Play.

Immediately at the end of each Entry Period, one (1) entrant will be randomly selected from amongst all entrants for the Contest Play and, upon verification of eligibility and compliance with the Contest Rules, such entrant will be qualified for the chance to win the one (1) Grand Prize (*as described in Section 7 below*) in this Contest (each, a “**Qualifier**” and collectively, the “**Qualifiers**”). Qualifiers will be notified the day of selection.
 - a. There will be up to ten (10) Qualifiers in this Contest.
 - b. No individual may be a Qualifier more than once in this Contest.**
 - c. There is no prize associated with being a Qualifier in this Contest.
5. On or around Monday, September 28, 2026, one (1) Grand Prize Winner (the, “**Grand Prize Winner**”) will be randomly selected from amongst the up to ten (10) Qualifiers in this Contest and will receive the one (1) Grand Prize (*as described in Section 7 below*).
6. The odds of becoming a Qualifier in this Contest depend upon the number of entries received. The odds of a Qualifier becoming a Grand Prize Winner in this Contest will be up to, but in no event greater than 1:10.

Prize(s)

Icelandair gift certificate expires on Thursday, September 30, 2027.*); (ii) three (3) nights hotel accommodations (one (1) room, standard double occupancy) at Grandi by Center Hotels, located at Seljavegur 2, 101 Reykjavík, Iceland, checking in on Thursday, November 5, 2026 and checking out on Sunday, November 8, 2026 (*Grand Prize Winner is responsible for all incidentals, valid credit card required for check-in, valid only for the dates listed only*); and (iii) two (2) 3-day GA wristband tickets to the Airwaves Music Festival, Thursday, November 5, 2026 through Saturday, November 7, 2026 in Reykjavik, Iceland (*Grand Prize Winner must pick up wristbands onsite at Airwaves Music Festival Will Call*) (the, “**Grand Prize**”). The Grand Prize is valued at approximately \$2,350.00 and is courtesy of Icelandair, Center Hotels, and Iceland Airwaves.
