On Wednesday, June 5, 2024, I responded to a possible brandishing call at [REDACTED] Home address [REDACTED]. I was informed that a Collin Bailey, who goes by Mia, had called in stating that the land lord of the house had pointed a shot gun at him and told him that he was going to shoot him. I arrived and made contact with Mia and asked what had happened. Mia stated that the land lord, Joseph Earl, had come in and began threatening him but Mia was unable to give any real specifics about what had happened. I asked Mia about the Gun and he stated it was a shotgun but that he hadn't seen it and didn't know what it looked like and had only heard it.

I made contact with Joseph who informed me [REDACTED] Clearly Unwarranted Invasion of Privacy [REDACTED]

Clearly Unwarranted Invasion of Privacy [REDACTED]. Joseph denied ever talking to Mia or having any confrontations with him. I observed that Joseph's wife came outside and confirmed that Joseph has been in bed sleeping all night and at no point had he gone and talked to Mia about anything. While talking with Mia he began talking about anti recording devices and a device that Joseph had in his room that would cause him to get headaches. I asked Mia if he had been diagnosed with any mental illnesses and he denied having any. I determined that there hadn't been any law violations or evidence that any threats had been made or weapons brandished. I informed Mia of this and advised her to leave Joseph alone and that once she had moved out of the house in the morning she wouldn't have to worry about Joseph or his devices anymore. Mia agreed and agreed to leave Joseph alone for the night. No law enforcement actions taken, my body camera was active.
